III. School Climate

School Safety Plan (School Year 2008-09)

This section provides information about the school's comprehensive safety plan.

Students are greeted by the principal, parent volunteers, and three yard supervisors each morning before the start of the school day. Staff at Point Dume regularly participates in trainings designed to help students better manage their own behavior, mediate conflicts and to develop social problem solving skills. Teachers incorporate the Cool Tools program. The program assists students in the development of problem-solving skills that enable them to reflect on decision-making, self-advocacy and foster skills that encourage and support their personal resiliency. After school, the PTA offers enrichment programs for students. The City of Malibu also facilitates the use of our playground for after school youth activities. During the school day, there is no unauthorized access to the school campus. Only one entrance is open during the school hours. All visitors are required to check in at the front office. They must sign in and wear a visitor badge. Point Dume Marine Science School is committed to a safe learning environment for all students and staff.

Staff have a specific meeting location as well as a staff lounge. Staff and students regularly participate in fire, earthquake and other safety drills throughout the school year.

IV. School Facilities

School Facility Conditions

This section provides information about the condition of the school's grounds, buildings, and restrooms, and a description of any planned or recently completed facility improvements.

Classrooms meet specific square footage guidelines and are equipped with whiteboards, classroom libraries, computer stations (minimum of 5 per classroom), Smart Boards in grades 3 - 5 and the multimedia center, audiovisual equipment and support materials. Classrooms also reflect a learning environment that allows students to work in whole group, small group, and independently. The playground is equipped with both a blacktop area as well as a large field for physical activity.

All Proposition X Bond construction was completed and final upgrades made. Our buildings have adequate space for our fourteen classrooms and 282 students. The large playground and lush field are adequate for our current population. We enjoy a healthy partnership with local businesses and the Point Dume Home Owners Association that enables us to serve the needs of our community members. The District Maintenance Department maintains the grounds and repair of the buildings. The facilities which support our school are well-maintained and are in well-functioning condition.

The district participates in the State School Deferred Maintenance Program, which provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. For the 2008-09 school year, the district budgeted \$500,000 for the deferred maintenance program. This represents 0.4 percent of the district's general fund budget. Needed maintenance includes routine roof maintenance to keep warranties in effect. Deferred maintenance projects include bathroom partitions and water line replacement/upgrades. We are proud that our school district takes great efforts to ensure that our school is clean, safe and functional. There are no emergency needs as defined by the Office of Public School Construction.

Planned Improvements (School Year 2009-2010)

PDMSS will be receiving upgraded infrastructure through Measure BB funds. All internet and connectivity speeds will be dramatically increased. The school exterior has been painted. With deferred maintenance funds, PDMSS installed a new septic system to replace the old tanks.

Point Dume Marine Science School's share of the Equity Fund is also used for this purpose. A portion of School and Library Improvement funding is used to purchase books for the library. GATE funds are used to provide classroom instructional materials to support differentiated instruction in 4th and 5th grade classrooms. GATE funds also make it possible for PDMSS to offer after school Literary Magazine and advanced technology classes for eight weeks.

IX. Student Performance

Standardized Testing and Reporting Program

The Standardized Testing and Reporting (STAR) Program consists of several key components, including the California Standards Tests (CSTs); the California Modified Assessment (CMA), and the California Alternate Performance Assessment (CAPA). The CSTs show how well students are doing in relation to the state content standards. The CSTs include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and ten through eleven. The CAPA includes ELA, mathematics, and science in grades two through eleven, and for science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations. The CMA includes ELA and mathematics for grades three through eight and science in grade five and is an alternate assessment that is based on modified achievement standards. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations. Student scores are reported as performance levels. National Assessment of Educational Progress

The National Assessment of Educational Progress (NAEP) is a nationally representative assessment of what America's students know and can do in various subject areas. Assessments are conducted periodically in mathematics, reading, science, writing, the arts, civics, economics, geography, and U.S. history. Student scores for reading and mathematics are reported as performance levels (i.e., basic, proficient, and advanced) and the participation of students with disabilities (SD) and English language learners (ELL) is reported based on three levels (identified, excluded, and assessed). Detailed information regarding the NAEP results for each grade, performance level, and participation rate can be found on the National Assessment of Educational Progress Web page at <http://nces.ed.gov/nationsreportcard/>.

Note: Only a sample group of California's schools and districts participate in the NAEP testing cycle. Therefore, students in any particular school or district may not be included in these results. The NAEP reflects state test results and is not reflective of either the LEA or the individual school. Comparisons of student performance on the NAEP and student performance on the Standardized Testing and Reporting (STAR) Program assessments cannot be made without an understanding of the key differences between the two assessment programs. For example, the NAEP only assesses grades four, eight and twelve and for long-term trends assesses grades nine, thirteen, and seventeen. Additionally, the NAEP only provides state test results for grades four and eight. The California Standards Tests (CSTs) are based on a different set of standards than the NAEP assessments. For example, the NAEP is not aligned with California academic content and achievement standards and, therefore, does not necessarily reflect the curriculum and instruction to which students are exposed in the classroom. The NAEP assesses reading and writing separately, while the CSTs assess English-language arts (ELA), encompassing reading as well as writing conventions, spelling, and grammar. Scores on the CSTs and other assessments are not directly comparable to those on NAEP. The averages and percentages presented are estimates based on samples of students rather than on entire populations. Finally, the questions students respond to are only a sample of the knowledge and skills covered by the NAEP frameworks. All teachers and staff at school sites participate in ongoing professional development through banked time, a total of 90 minutes of meeting and professional development time each week at each site. In addition, there are up to three days set aside in our academic calendar for intensive professional development and planning.

Areas of district-wide focus for teacher and administrator professional development include implementation of newly adopted textbooks and other areas that are determined by a review of summative and formative data from all school sites and the collection of input from teachers and administrators. Among the primary focus areas for professional development in the SMMUSD schools are the following:

- *Developing Instructional Leadership Teams and Professional Learning Communities through Lesson Link, Academic Conferences and Learning Walks
- *Literacy and Mathematics -- standards based curriculum and instructional delivery
- *Using data to improve classroom instruction
- *Culturally relevant and responsive pedagogy
- *Supporting students with special needs
- *Differentiated Instruction for all students, including English Learners
- *Technology integration

A variety of methodologies are used to provide professional development, including coaching and mentoring. SMMUSD provides coaching through several programs such as BTSA, National Boards, literacy and ELD coaching, Instructional Leadership Teams, and such specialized programs as Cotsen Fellows and EETT Mentor/Coaches. Additionally, professional development occurs through workshop series during banked time and/or after school opportunities.

Each August, all teachers new to Santa Monica-Malibu are invited to participate in Teacher Academy, a professional development and orientation to district wide curriculum and instructional initiatives. All eligible new teachers are encouraged to participate in BTSA. Teachers interested in applying for National Board Certification may participate in the process and can elect to be supported by teachers who have already achieved National Board Certification.

In addition, each year, at individual school sites, teachers and administrators review data, discuss options and select additional areas of focus for the staff as a whole as well as for departments and/or grade level teams as appropriate.

PDMSS instructional focus has been on increasing fluency and reading skills of our students. We have provided targeted instructional strategies as well as differentiated instructional training to improve overall academic achievement. We currently have 4 national board certified teachers who provide on site professional development to teachers as part of their professional duties and responsibilities.

We have also focused on mathematics instruction, specifically on refining problem solving techniques. Incorporation of smartboard technology in every classroom has provided unique opportunities for both our teachers and students.
