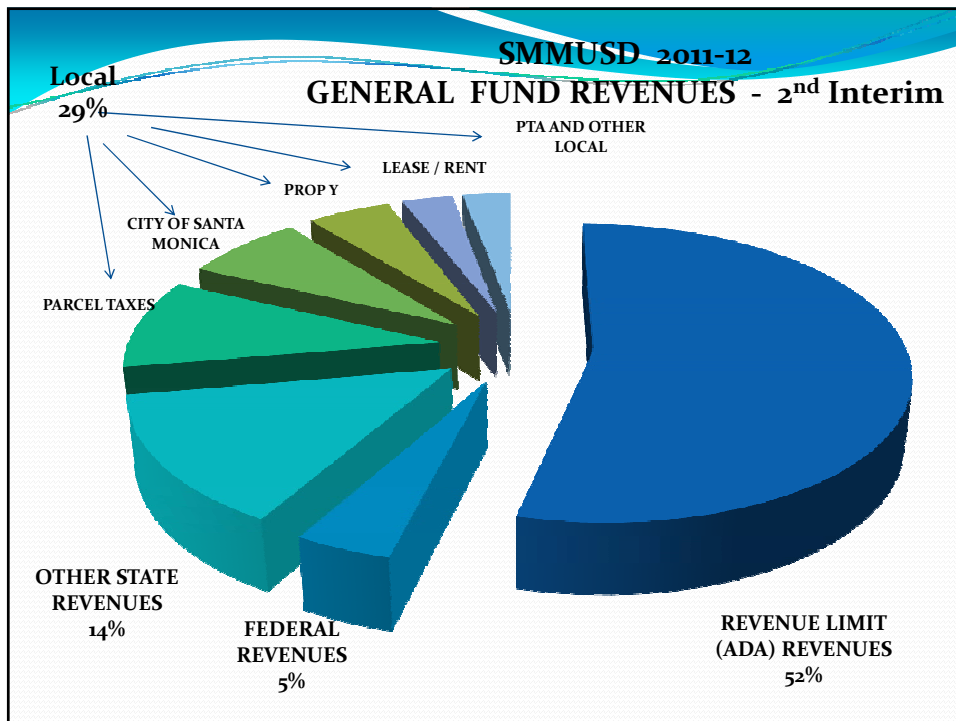
Revenue Sources

• Revenue Limit	52%
• Federal	5%
• Other State	14%
• Local	29%
• Parcel Taxes	9%
• City of Santa Monica	7%
• Prop Y	5%
• PTA and Other Local	5%
• Rents and Leases	3%

Revenue Sources – in millions

- Revenue Limit • \$ 58.2
- Federal • \$5.6
- Other State • \$15.6
- Local • \$32.7

- TOTAL • \$112.1

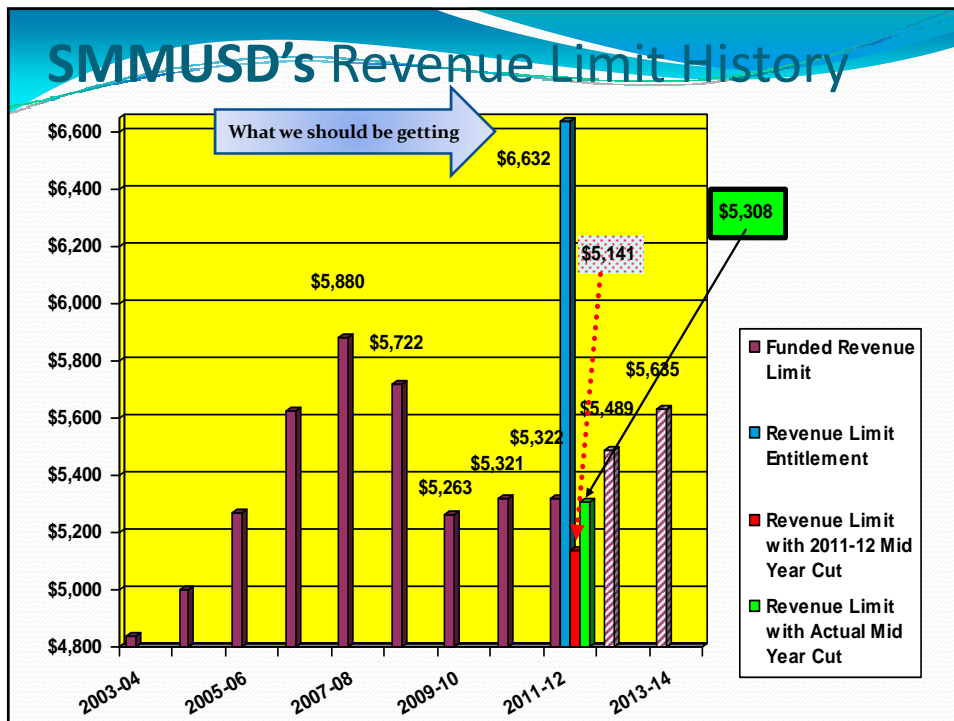


Revenue Limit

- Per student entitlement
- Calculated on the basis of Average Daily Attendance (ADA)
- Comprised of two components
 - Local Property Taxes
 - State Aid
- If one component increases the other decreases

Before possible mid year reductions

- 2011-12 SMMUSD Revenue Limit Entitlement should be \$6,631.61/ADA
- State deficit applied to the entitlement - 19.754%
- 2011-12 funded Revenue Limit is \$5,321.60/ADA



Federal Revenue

- *Categorical Funds that have specific expenditure requirements – funds are restricted by legislation*
- Title I, II, and III - \$2.1 million
- Special Education IDEA Entitlement (federal portion only) - \$2.4 million
- Other federal programs - \$683,000
- One time funds in 2011-12
 - ARRA – including carryover Jobs dollars - \$417,000
- TOTAL - \$5.6 million

Other State Revenue

- *Categorical Funds that have specific requirements*
- *Combination of **Restricted** and Unrestricted funds*
- **Special Education (AB 602) - \$5.9 million**
- Tier III flexibility funds - \$4.5 million
- Class-size Reduction - \$2.2 million
- Lottery
 - Unrestricted - \$1.3 million
 - **Instructional Materials - \$182,000**
- **Transportation (Regular and SPED) - \$800,000**
- **EIA - \$767,000**
- TOTAL - \$15.6 million

Local Revenue

- Revenue from our local communities of Santa Monica and Malibu
- Includes both voter approved and donated funds
- Parcel Taxes (Measure R) - \$10.7 million
- City of Santa Monica (Master Facility Agreement) - \$8.1 million
- Prop Y and YY - ½ cent sales tax (Santa Monica only) - \$5.5 million
- Leases and Rent - \$3.3 million
- All Other - \$5.1 million
 - Donations - \$3.5 million
- TOTAL - \$32.7 million

Counselors/Advisors	Secondary Schools only Funded by Lottery – Advisors Funded by General Fund and Prop Y - Counselors
Librarians/Library Asst.	Secondary/Elementary Funded by Measure R
Site Administration	Principals, House Principals, Assistant Principals, Dean of Students (Samohi)
Clerical	Admin. Assistants, Attendance Clerks, Office Specialists
Custodial	Based on CASBO formula Plant Manager at Samohi
Noon Duty Aides	Based on School configuration and need
Physical Activity Specialists	Fund by Measure R
Security Officers	Secondary only
Life Guards – PE Aides	Secondary only - Funded by Measure R
Music Aides	Secondary only - Funded by Measure R (Elementary Music in Ed Services Budget)
