# MINUTES (draft only)

**Attendees:** Deborah Berek, Janis Gabbert, Zina Josephs, Lydia Murraro, Dominic Piturro, John Redfield, Rebecca Cardenas, Maria-Leon Vazquez, Richard Tahvildaran-Jesswein, and Tom Whaley

- 1. The meeting was called to order at 7:07 PM by Co-chair Janis Gabbert.
- 2. Minutes from the April meeting were approved by unanimous consent. (Muraro)

- 3. **P.S. ARTS** Rebecca Cardenas reported that they will wrap up programs by the first week of June. Two more Family Art Nights are scheduled.
- 4. **Administrator Co-Chairperson** -- Dr. Jacqueline Mora was unable to attend.
- 5. **Staff Liaison and VAPA Coordinator** -- Tom Whaley's report:
  - a. The Mexico Magico ballet folklorico event at Samohi was a great success.
  - b. The Mariachi group performed for Cinco de Mayo at Will Rogers. The groups will rehearse twice a week next year.
  - c. ACES discussions with music and theater teachers continue at Samohi.
  - d. An art show will open at the Roberts Gallery at Samohi on May 12.
  - e. New funding from Measure R for VAPA programs will be available in 2022-23, specifically for non-capital expenses such as instruments, choir risers, orchestra shells for the middle schools, etc.
  - f. If the statewide "Vote Arts and Music" initiative passes in November, the Art teachers would like instructional aides to help with special needs students.
  - g. The Kiwanis music scholarship winners' performances and reception will be on May 25.
  - h. The Samohi Master Schedule committee, led by Dr. Drati, met on May 10.
- 6. **Board of Education Liaisons** Maria Leon-Vazquez reported that the 2022-23 budget is not yet complete. There seems to be an "aspirational agreement" with the Malibu City Council regarding unification (creating a Malibu Unified School District). Maria has been advocating for English Language Learners to be re-classified as soon as possible so they can take electives in high school. Richard TJ asked about the status of the Dance program at Samohi. Tom replied that he set up meetings with Samohi administration and SMC, and that there will be one dual-enrollment class in the Fall. Staffing and curriculum have not yet been finalized.
- 7. **Year-End Report** The draft report was discussed, revised, and approved by unanimous consent. (Josephs)

- 9. The rest of the agenda items were tabled.
- 10. The meeting was adjourned at 8:57 PM.
