How Can You Help Your Child?

- Meet with your child's teacher/counselor
 - What criteria is your child not meeting for reclassification?
 - How is the teacher supporting language acquisitions?
 - How can you work as a team to support the identified area of need?
- Talk to your child about their goals
 - What is your child interested in?
 - What career would they like to pursue? (Dreams)
 - How do they begin to prepare in elementary, middle school and high school to achieve their dream career? (Create a plan)
 - Are they making progress towards their goals? (Re-evaluate their plan and adjust)
 - It is alright if the career or dream changes as students progress through their educational journey.



How Can You Help Your Child?

- Create a learning space
 - A location that you identify and create as a family to support learning at home.
- Identify a time when you can read and discuss what you are reading as a family
 - Start with 5 to 10 minutes a day
