- b. Counselors have been informing 10th graders that they can't take U.S. history at SMC this summer because only Samohi's U.S. history class will fulfill the new ACES graduation requirements. This policy impacts not only VAPA students' schedules, but all students' abilities to take UC-approved classes that are transferable to many colleges where AP classes may not be. Why is SMMUSD imposing this requirement now when the state law, AB-331, doesn't take effect until 2025?

A local educational agency, including a charter school, may require a full-year course in ethnic studies at its discretion. Commencing with the **2025–26** school year, a local educational agency, including a charter school, with pupils in grades 9 to 12, inclusive, shall offer at least a onesemester course in ethnic studies.
