2. Campus trespasser/unauthorized photography last week: The person taking pictures has been interviewed by sheriff. While he committed no crime per sheriff, per Diane, the sheriff told him it's best to refrain and apparently he agreed. Staff will continue to tell him not to take photos as this is our duty to protect students with a no photo request on file.
 - a. Perimeter Camera updates: We've been asking for these for three years and were told at the beginning of this year that they were coming. The latest update is to have cameras installed and functioning at MES by the beginning of school in August. Hertz should be receiving the draft layout of cameras for MES in the next 2 weeks.
2. Raptor System: Is it being used to its full potential? Examine the permanent badge system - how are names run? Do we have a complete list of visitors on campus at all times? (Balance between convenience and protocol)
3. Fire Alarm Causing Trauma for Student Fire Victims Last Week: The fire alarm has gone off 3 times in four weeks:
 - a. One event was triggered by the same sensor that triggered 3 times at the beginning of the year. It was replaced it then and due its proximity to a vent, a vent deflector was installed. Maintenance replaced the sensor again when this one happened.
 - b. The other two were legitimate: MBGC was using a microwave to cook food and it burnt. The smoke triggered the sensor. MBGC has promised to be more careful. Today, the tea kettle in the staff lounge triggered the sensor as it produced a lot of steam.
