V ELAC Discussion /Recommendation: Elections/formation of a formal ELAC did not take place.

VI Other presentation(s): Debbie Stern, AP, explained how Roosevelt supports EL students. The home language survey and ELPAC testing was explained. School demographics were shared. Parent/Teacher conferences were explained, along with a list of anticipated subjects discussed during conferences. The CREST lead spoke to attendees about programming and how to get their child into enrichments or on waiting lists for childcare. The liaison explained PEACHJAR and reviewed the district and school websites. CREST applications were made available for anyone desiring. Parents asked several questions during the meeting, including those regarding teachers' knowledge of their EL students, important questions to ask during conferences, programs offered to EL students at Roosevelt, how to attend JAMS immersion program if the student is on the Lincoln pathway, and other questions pertinent to the CREST program.
