RECOMMENDATION NO. A.06a

It is recommended that the Board of Education approve the Application for funds for the Equipment and Supplies for California Career Technical Education Program Grants in the amount of \$4,518.00 for the 2006-2007 school year.

COMMENT: The California Department of Education is offering a one-time allocation for Career Technical Education (CTE) programs for fiscal year 2006-07. (Funds unexpended during the 2006-07 fiscal year may be carried over to the next fiscal year.) Chapter 79, Statutes of 2006, Section 43 (14) (Assembly Bill 1802) allocated \$40 million statewide for CTE programs. Of this amount, \$37.5 million was appropriated solely to support CTE programs. The district's allocation, which is based on the number of students enrolled in CTE courses during the 2006-07 school year, is \$4,518.00.

RECOMMENDATION NO. A.06b

It is recommended that the Board of Education approve the Career Technical Education Application for Funding Carl D. Perkins Career and Technical Education Act 1999, for secondary schools in the amount of \$59,034.00 for the 2007-2008 school year.

COMMENT: It is the purpose of the Carl D. Perkins Career and Technical Education Act to make the district's students more competitive by developing more fully the academic and occupational skills of all segments of the student population. This purpose will principally be achieved through concentrating resources on improving educational programs leading to academic, and career/technical skill competencies needed to work in a technologically advanced society. These federal funds may only be used for program improvement at secondary school sites.
