December 11, 2008

A regular meeting of the Santa Monica-Malibu Unified School District Board of Education was held on Thursday, December 11, 2008, in the District Administrative Offices: 1651 16th Street, Santa Monica, CA. The Board of Education called the meeting to order at 4:20 p.m. in the Board Conference Room at the District Offices: 1651 16th Street, Santa Monica, CA. At 4:21 p.m., the Board of Education moved to Closed Session regarding the items listed below. The public meeting reconvened at 5:49 p.m. in the Board Room.

IV. BOARD OF EDUCATION – COMMENDATIONS / RECOGNITIONS (30)

5:50 pm

- Outgoing Board of Education President and Vice President
Superintendent Cuneo welcomed Ben Allen to the board. He said it has been a pleasure working with both Mr. de la Torre and Dr. Escarce to help provide direction for the district. He added that even though they were leaving their current roles, he knew that they would continue their leadership on the board. On behalf of the district, he thanked Mr. de la Torre and Dr. Escarce for their contributions. Both men were presented with glass plaques engraved with their names and terms of service.

Mr. de la Torre said it has been a pleasure serving as President during a difficult time in the district. He thanked the board for the opportunity his colleagues gave him. Dr. Escarce thanked his colleagues as well. He thanked Superintendent Cuneo and senior staff for their tremendous contributions to the district.

5:55 pm

- Santa Monica Alternative School House (SMASH) (10)

Principal Rishe began her report by recognizing the parents and peers who showed up tonight. Fifth grade teacher, Jeanie Lang, informed the board of SMASH's math focus. Ms. Lang is in her second year of teaching at SMASH. Prior to coming to SMMUSD, she taught in New York, where the focus on staff development and student learning proved successful. She informed the board that SMASH focuses on students as learners. She then explained SMASH's approach to teaching math. K-4 teachers have been trained in CGI, a math program. Algebra teachers focus on algebra in real-life approaches. She thanked the board for letting the school choose a curriculum that matches its goals and philosophies. Ms. Lang said that SMASH allows teachers to be the experts, to think, reason, and discuss mathematics. It also lets the students construct their knowledge; rather than telling the students how to do math, students are allowed to discover math concepts themselves. The district has started a math study group, where teachers are brought together to strengthen their own knowledge and practices. A fifth grade student named Gigi demonstrated how to see fractions in a context as part of a whole number and how estimation can help interpret fractions. Fifth grade student Dylan explained math games the students play to help engage in the task and assess their learning. Another fifth grader explained his reasoning behind fractions.

6:13 pm

- John Muir Elementary School (10)

Principal Tristan Komlos thanked the board for the opportunity to present. She began her report by saying Muir's students have been doing amazing over the past years. Math achievement has gone up over 50% in proficiency. The school will be starting a student council. Ms. Komlos highlighted the tremendous staff at Muir and summarized some of the site's programs, including standards-based curriculum with a focus in math. Ms. Komlos pointed out that CST scores reflect targeted math instruction by teachers and support from the district. Intervention programs include reading/literacy support, an afterschool teacher-guided homework club, and Mathematicians, which provides targeted math instruction. Art instruction is provided weekly, and student art work is displayed all over the school. Science enrichment also occurs weekly, and fourth graders take an annual field trip to the Channel Islands, while fifth graders visit science camp at Camp Hess. In regards to technology, Muir has a computer lab, SMART Boards, and ELMO projectors. Students at Muir also experience music weekly.

PTA President Helene Sesiay explained that the PTA does quite a bit of fundraising and fun-raising. Fun Raising activities include the Halloween Carnival, Coastal Clean Up, Garden Club, Spirit Day, Back-to-School Picnic, Intercultural Festival, and the STAR test rally and dance. Fundraising consists of a jog-a-thon, direct donation drive, art and antique fair, and class fundraisers.

Ms. Komlos added that the site provides for before and after school care for families collaboratively with the CREST program. On behalf of all her students, Ms. Komlos thanked the board for its support and advocacy.

A. Student Board Member Reports

6:30 pm

Jaime Black – Santa Monica High School (3)

Student Board Member Black reported that LA Times reported Steve Lopez spoke at Barnum Hall yesterday about his book The Soloist. The SAMOHI orchestra then performed with special guests Ben Hong, Antonio Lysy, Guido Lamell, Maragret Lysy, and Daniel Thomason. The Winter Film Festival was held on December 3rd, during which the talented students of SAMOHI showed short films they wrote, produced, and directed. The Clothing Drive ended, and O House won with over 1,000 article of clothing. All donations will be given to the Salvation Army and the proceeds from the clothes sales will be given to the fire victims. The S House canned food drive brought in about 500 cans of food. The canned food drive among the Homerooms ends on December 17th. The Orchestra Winter Concert will be held on December 16th and the Choral Winter Concert will be held on December 18th. Yearbook will be holding a fundraiser on December 17th. Also on that day will be the last Bike to School Day of 2008. The SAMOHI Marching Band is going to London, England to perform in the New Years Day parade. She Loves Me, a classic Broadway play, will be performed on December 12th, 13th, 19th, and 20th in the Humanities Center.

Student Board Member Sahafi reported that the play Metamorphosis was performed December 4th -7th. On December 3rd, there was a push up contest in the cafeteria, during which students played music and won Malibu Yogurt gift cards. The girls' soccer team played against Pacifica today and girls' water polo played Harvard Westlake. Yesterday was the first House of Representatives meeting. Discussions at the meeting addressed healthier food on campus, school spirit, and lunch time

SMMCTA Vice President Sarah Braff announced that after many years and a lot of struggle, the new elementary school report card is ready for use. The new report card format still maintains the standards-based approach, but are now more user-friendly for teachers, students, and parents. She thanked the teachers, principals, district staff, and parents who worked together to create this new document. The new report card will be presented to the PTA Executive Board in January.

Ms. Cartee-McNeely said it was great working with President de la Torre and Vice President Escarce. She welcomed Ben Allen to the board.

6:47 pm

D. PTA Council – Rebecca Kennerly (5)

Ms. Kennerly thanked Mr. de la Torre and Dr. Escarce for their leadership. She welcomed Mr. Allen to the board. Ms. Kennerly reported that the annual PTA breakfast was successful. Members met today to continue the process of assessing what the school site PTAs pay for. The PTA will create a comprehensive overview of PTA expenses, prioritizing those items that should be funded by the district. Board President de la Torre thanked Ms. Kennerly for the PTA breakfast.

X. SUPERINTENDENT'S REPORT (5)

6:50 pm

Mr. Cuneo began his report by commenting on the state budget crisis. The district is putting together a budget development process that will carefully look at how we are spending dollars to educate our children. He commented that the goal of the district is to develop a budget that will help sustain the type of education our students deserve without help from Sacramento. Tonight, Ms. Maez will show multi-year projections under various scenarios. He stressed that the district will be careful and strategic in order to avoid the chaos that other districts may face.

Mr. Cuneo updated the board regarding the communication audit, which they approved at a previous board meeting. Because of the holiday season, the interviews with district staff and community members will be held in mid-January. The consultant is currently examining the district's web site, printed materials, press releases; etc.

The Parent Resource Network training has been completed. The next step is the set the roles. The network has been working closely with the PTA and staff to carry out initial training that was provided by San Ramon. San Ramon has asked if they could use our handbook as a model in order to share our success with others.

Mr. Cuneo reported that he attended the PTA breakfast last week. He can't thank the PTA enough for their contributions and Rebecca Kennerly for her leadership.

Superintendent Cuneo reported that there was a Measure BB meeting the past Monday in Malibu. It was a general information meeting, and the spirit was far more positive than in the past. Malibu residents who had claimed that they were not receiving adequate information said that they felt more informed and a part of the process. Future meetings will be held to discuss field lighting and the traffic study. Ms. Maez clarified for Ms. Pye that traffic studies would also be held in Santa Monica as part of the CEQA process. Mr. Allen encouraged his fellow board members to attend these meetings. Mr. Mechur asked about the palm trees at the high school. Mr. Cuneo replied that there was a five-year plan to beautify the campus and plant palm trees along the parking lot. There was initial concern about the fire hazard and height of the palm trees. The district is working to ensure the species of the palm trees fit the fire safety and zoning standards.

To conclude his report, Mr. Cuneo announced that Edison Elementary School has been nominated as a Blue Ribbon School. He remarked on the school's hard work.

It is recommended that the Board of Education accept, with gratitude, the generous donation from NIKE, Inc. and LA84 of the refurbishment of the track at Samohi.

**GIFT AGREEMENT FOR TRACK REFURBISHMENT
Santa Monica High School**

Effective Date: December 11, 2008

Whereas:

- A. NIKE, Inc. is a leading designer, marketer and distributor of authentic athletic footwear, apparel, equipment and accessories for a wide variety of sports and fitness activities;
- B. NIKE and its affiliates such as NIKE USA, Inc. (collectively "NIKE") support communities through programs designed to get kids active;
- C. In particular, NIKE has created a program called "Let Me Play" which provides grants to community groups and government entities to support the promotion of sport to get youth active and as a means for positive social change in many other ways;
- D. Through its Reuse-A-Shoe program, NIKE promotes recycling by grinding up waste from the manufacture of athletic shoes and grinding up used athletic shoes and equipment to create a material called "Nike Grind" which, in turn, NIKE desires to be used in play surfaces installed pursuant to Let Me Play grants;
- E. The LA84 Foundation ("LA84 Foundation") (formerly the "Amateur Athletic Foundation"), supports a wide array of youth sports programs in the greater Los Angeles area;
- F. NIKE and LA84 Foundation intend to partner in a number of Let Me Play sport surface donations in the Los Angeles area over the next year or two;
- G. The Santa Monica - Malibu Unified School District is a public school district organized under the laws of the State of California.
- H. Santa Monica - Malibu Unified School District seeks to promote active sports play among youth enrolled in its schools;
- I. NIKE and LA84 Foundation wish to award and the Santa Monica - Malibu Unified School District wishes to accept a refurbished running track at Santa Monica High School as more fully described below.

Pursuant to this Grant Agreement ("Agreement") dated December 1, 2008 (the "Effective Date"), NIKE USA, Inc. and LA84 Foundation ("Grantors") hereby agree to award a grant to the Santa Monica – Malibu Unified School District ("Grantee"), and Grantee hereby accepts such grant, on the terms and conditions set forth below.

- 2. **Deliberately Left Blank.**

3. The Grant Project. Grantor LA84 Foundation shall contract with Atlas Tracks, Inc. dba "Atlas Track & Tennis" (Atlas) for the refurbishment of the 400 meter, 6 lane track (the "Track") at Santa Monica High School, located at 601 Pico Boulevard, Santa Monica, CA 90405 (the "Project Location"). The contract between LA84 Foundation and Atlas shall expressly state a requirement that Atlas use a Nike-authorized installer for the resurfacing of the Track. Grantors' names, logos or other identifying marks may be incorporated into the design of the Track (e.g., the LA84 Foundation, NIKE, NIKE Swoosh, NIKE Grind and/or Let Me Play logos painted on or around the Track), subject to Grantee's reasonable approval. The goal is for the Track to be operational by January 2009. Funds for the refurbishment of the Track shall be provided by Grantors NIKE and LA84 Foundation. The Track refurbishment project is valued at one hundred thousand dollars (\$100,000).

Grantee shall not be responsible for expenses related to the refurbishment of the track including supplies, materials, or labor.

4. Grantee's Covenants: Grantee hereby covenants that, in order to induce Grantors to enter into this Agreement and to award the Grant:

- (a) Grantee will maintain the Track in a safe and attractive manner consistent with Grantors' image and reputation, the terms and conditions of the product warranty, and appropriate industry and community standards;
- (b) Grantee owns the Project Location, and the Project Location is free of any liens, encumbrances or third-party claims that would be inconsistent with the Grantors' intent that the Track be used for recreation and play activities;
- (c) Grantee shall obtain, or shall assist contractor Atlas Track in obtaining, all necessary permits, authorizations and consents, as well as right of entry to the Project Location to perform the necessary work; and
- (d) Grantee shall ensure that the Track shall be used exclusively for sports and recreation activities during the term of this Agreement.
- (e) Grantee is authorized to enter into this Grant Agreement.

5. Status: Grantee affirms that it is tax-exempt to the same extent as other public entities within California.

6. Grantee's Books and Records: Grantee agrees to maintain sufficient operating and financial books, records and related documentation regarding the Grant, the Track, and the activities of Grantee, and to allow Grantors reasonable access to such books and records as they relate to the implementation of this Agreement.

7. Publicity, Recognition and Partnership Opportunities:

- (a) Grantee shall acknowledge Grantors NIKE and LA84 Foundation as grant partners in its written material, news releases and related marketing or publicity including, but not limited to, a kick-off press conference and the Track dedication ceremony.
- (b) Grantee agrees to assist and cooperate in a mutually acceptable dedication event at the Track.
- (c) Grantors also shall have the right to publicize, show photographs of, use the name of the Track and otherwise promote its contribution.
- (d) Grantors will be given usage of the Track for up to three (3) sports events per year upon reasonable notice and subject to Grantee's reasonable approval. Grantee shall not charge Grantors a fee for use of the Track for

these events but may charge Grantors for Grantee's personnel expenses for staff supervision during the event(s).

- (e) Grantors shall have the right (but not the obligation) to place and remove its logos or trademarks on or around the Track, subject to the prior approval of Grantee. The use of any name for the Track shall be subject to the prior approval of Grantors and Grantee, subject to Grantee's naming policy, with prior notice to Grantor.
- (f) Grantors shall have the right, at Grantor-held events at the Track (e.g., events as described in 7(a) or 7(d) above), to operate a non-retail booth or similar area for promotional purposes. The size and location of the booth or similar area shall be subject to Grantee's reasonable approval

8. **Absence of Grantor Warranties:** GRANTORS MAKE NO REPRESENTATIONS OR WARRANTIES HEREUNDER OF ANY KIND, EXPRESS OR IMPLIED, AS TO ANY MATTER INCLUDING IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY OR OTHERWISE RELATING TO THE TRACK OR ANY COMPONENT THEREOF, OR THE PERFORMANCE BY THE SURFACE CONTRACTORS OF ANY SERVICES. IN NO EVENT, EXCEPT AS PROVIDED IN PARAGRAPH 9, WILL GRANTORS BE LIABLE FOR ANY DAMAGES INCLUDING PERSONAL INJURY, LOST PROFITS, OR OTHER CONSEQUENTIAL, EXEMPLARY, INCIDENTAL OR PUNITIVE DAMAGES ARISING OUT OF THIS AGREEMENT OR THE PLAY AREA.

9. **Indemnification:**

- (a) Except for the active negligence or willful misconduct of Grantor NIKE or LA84 Foundation, or any of Grantors' officers, directors, employees, accountants, attorneys, agents, affiliates, subsidiaries, successors, insurers and assigns, Grantee agrees to indemnify, defend and hold harmless Grantors NIKE and LA84 Foundation and Grantors' officers, directors, employees, accountants, attorneys, agents, affiliates, subsidiaries, successors, insurers and assigns from and against any and all third party claims, demands, losses, damages, liabilities, costs and expenses (including reasonable legal/attorneys' fees and expenses arising out of or related to any legal proceeding and any legal appeal) related to the Grant, the Track, or this Grant Agreement and liabilities of any kind or nature whatsoever, whether in contract, tort, or otherwise, resulting from any claim (including, without limitation, personal injury, death, or property damage) actually or allegedly arising out of or in connection with the negligent acts, errors, omissions or willful misconduct, including the maintenance, location, or condition of the Track, or any person's use of the Track, whether authorized or unauthorized, proper or improper. Without limiting this obligation, Grantee will maintain the insurance described in Section 10 below.
- (b) Except for the negligence or willful misconduct of the Santa Monica - Malibu Unified School District or any of its Boards, Officers, Agents, Employees, Assigns and Successors in Interest, Grantors, during Grantor-sponsored special events (including the operation of booths or similar area for promotional purposes) undertakes and agrees to defend, indemnify and hold harmless the Santa Monica - Malibu Unified School District and any of its Boards, Officers, Agents, Employees, Assigns and Successors in Interest from and against all suits and causes of action, claims, losses, demands and

expenses, including, but not limited to, attorney's fees and cost of litigation, damage or liability of any nature whatsoever, for death or injury to any person, including Grantors' employees and agents, or damage or destruction of any property of either party hereto or of third parties, arising in any manner by reason of the negligent acts, errors, omissions or willful misconduct incident during the Grantors' use of the Track or its use by Grantors' Contractors and Subcontractors of any tier.

10. Insurance Requirements:

- (a) Grantee shall obtain and keep in effect for the period of time the Track are in place, at Grantee's expense, the following insurance coverage:

11. Use of Marks: Notwithstanding any provision herein, neither party shall use the other's trademarks, tradenames or logos (each, a "Mark") without prior written approval. Each Mark shall remain the sole and exclusive intellectual property of the pertinent party.

12. Term: The term of this Agreement shall commence on the Effective Date and end five (5) years from that date.

DETAIL

The Santa Monica-Malibu Unified School District recognizes the rights inherent in the First Amendment of the Constitution of the United States and supports the principles of intellectual freedom expressed in the Library Bill of Rights and in Access to Resources and Services in the School Library Media Program. It is the policy of the district to provide information and instructional materials in classrooms and library media centers in accordance with constitutional protection. The Santa Monica-Malibu Unified School District supports a process for the systematic review of instructional materials through established procedures.

Legal responsibility for the operation of the district including the supervision of the selection of educational instructional materials rests with the Board of Education. The Board of Education delegates the authority for the selection of instructional materials to the professional staff employed by the district. It is the responsibility of the professional staff to select and use instructional materials to implement the educational program of the school district. Instructional materials must serve both the breadth of the curriculum and the needs and interest of individual students by accommodating a wide range of abilities and respecting diverse points of view.

Educational suitability is the major criteria for the selection of instructional materials. Professional staff are to use educational criteria and professional judgment rather than personal opinions, values, and beliefs in the selection of instructional materials.

Instructional Materials should:

- A. Be selected according to their alignment with the state frameworks and the general educational goals of the district.
- B. Be appropriate for the age, interests, abilities, learning styles, social development, and maturity levels of the students.

- C. Represent the diversity of religious, ethnic, political, and cultural values held in a pluralistic society.
- D. Illustrate the contributions made by various groups to our national heritage and the world.
- E. Illustrate historical and contemporary forces in society to enable users to recognize and understand social, economic, personal, and political problems.
- F. Provide various points of view about issues, including those considered to be controversial.

Certificated library media personnel and teachers should consider:

- A. Literary and artistic merit; technical quality; and physical condition appropriate to format and intended use.
- B. Scope, arrangement, and organization, relevance of information, special features, and overall value to the collection.
- C. Selection of instructional materials for specific courses to be consistent with the educational goals of the district, the objectives of the course, and the characteristics of the students.
- D. When selecting textbooks or materials for courses, it is imperative that administrators and faculty members avoid any appearance of a conflict of interest in assigning faculty-authored textbooks, supplemental books or instructional materials. While not expressly prohibited, the assignment of faculty-authored textbooks, supplemental books, or instructional materials should ensure that the teacher does not profit from this arrangement. Textbooks, supplemental books, tapes, software and other instructional materials authored by the course teacher may be assigned to be purchased by students or the District for a course taught by the author if the royalties arising from the purchase of the assigned materials are returned to the District, another educational institution, a charitable organization, or a not-for-profit foundation. A statement, signed by the author, outlining the approved disbursement of any royalties shall be retained on file by the District.

RECOMMENDATION NO. A.30

It is recommended that the Board of Education approve the 2008-09 First Interim Report and the corresponding budget adjustments.

COMMENTS: Education Code (*EC*) Sections §35035 (g), §42130, and §42131 require the governing board of each local educational agency (*LEA*) to certify at least twice a year as to the *LEA*'s ability to meets its financial obligations for the remainder for that fiscal year and for the subsequent two fiscal years.

The 2008-09 Budget was adopted by the Board of Education on June 26, 2008, and was approved by the Los Angeles County Office of Education (*LACOE*).

Since the adoption of the initial budget, changing conditions have necessitated adjusting the District budget. All of the expenditure and revenue changes previously approved by the Board or proposed for approval at this time are individually identified in the First Interim Report (October 31, 2008), which is included as a part of this document.

The First Interim Report was developed based on the following Revenue and Expenditure Assumptions.

REVENUE ASSUMPTIONS:

1. State Revenue Limit projection is based on a 5.66% COLA for 2008-09 (\$329 per ADA = 5.60% for SMMUSD). And the Deficit Factor is <4.71%>. The net decrease in Revenue Limit funding is **<\$1,324,632>**.
2. The Base Revenue Limit for Santa Monica-Malibu will be \$6,588,547 per 2007-08 P-2 ADA (11,065).
3. The Lottery allocation is currently estimated to be \$131.50 per annual ADA. Of this amount, \$19 is allocated for instructional materials.
4. The District will participate in the State's Class Size Reduction Program for Grades K-3 and will receive \$1,007 per pupil for Grades K-3.

5. No budget for Mandated Costs Reimbursement in 2008-09.
6. Special Education transfer from the Revenue Limit is \$1,929,388. Special Education Settlement at \$4.52 per 1999-00 ADA is \$52,328. The Special Education estimated funding for AB 602 is \$6,609,831, and the estimated federal funding is \$2,436,595.
7. Instructional Materials Funding Realignment Program will be funded at \$69 per pupil (October 2007 CBEDS -11,571).
8. The local Parcel Tax for Measure R at \$346 per parcel is estimated to generate \$10,300,420, after processing senior exemptions, which are anticipated to number 2,757 out of 32,527 parcels. The Measure R parcel begins in 2008-09 to replace the previous Measure Y and Measure S parcel taxes.
9. The District will receive \$7,443,913 of financial support from the City of Santa Monica.
10. The District will receive \$135,000 of Joint Use Agreement funding from the city of Malibu.
11. The combined lease revenue is \$2.64 million, which is from the Doubletree Hotel, Madison Site, 9th & Colorado and 16th Street properties.
12. There is \$800,000 estimated interest revenue for the Unrestricted General Fund.
13. The District will receive \$16.8 per pupil for the Arts and Music Block Grant.
14. The District will receive \$69 per 2007-08 CBEDS grade 7-12 for Supplemental School Counseling.
15. The total of \$1,268,392 for the 2007-08 deferred revenues is added to 2008-09 current revenues for various programs.

EXPENDITURE ASSUMPTIONS:

1. Full-Time Equivalent (*FTE*) Changes post budget adoption:
 - 1.0 FTE increase for Malibu High teaching position
 - 1.0 FTE increase for Will Rogers teaching position
 - 0.4 FTE increase for John Adams teaching position
 - 1.4 FTE increase for SAMOHI teaching Position
 - 3.65 FTE increase for Reading Specialists
 - 0.5 FTE increase for Ed Services teacher on Special Assignment
 - 1.0 FTE increase to restore the Dean of Students at SAMOHI

- 1.0 FTE increase for Principal on Special Assignment
- 1.0 FTE increase for Special Ed coordinator position

2. Salary:

No projections of salary increases are included, except the step and column increases for Certificated and Classified employees.

3. Statutory Benefits:

- 8.25 % STRS employer contribution rate
- 6.20% OASDI contribution rate
- 1.45% Medicare contribution
- 0.30% SUI contribution
- 2.00% Workers' Compensation contribution rate
- 9.428% PERS employer Contribution rate
- 3.592% PERS Reduction

4. Effective 1/1/2009, the premium rates for District-paid employee medical are increased as follows:

- Blue Shield (HMO) - 5.18%
- Kaiser Permanente - 8%

TRANSFERS

1. Due to our participation in the State's School Facilities Modernization Program, we are currently required to budget 3%(\$3,890,101) of the total General Fund budget for the Ongoing Maintenance Program.
2. A contribution of \$500,000 to the Deferred Maintenance Fund (Fund 14) has been budgeted, representing the estimated District match.
3. A transfer of \$1,000,000 from Fund 21 to the Ongoing Maintenance Program (Fund 01) is budgeted.
4. A contribution of \$75,000 to the Child Development Fund (Fund 12) has been budgeted for the extra costs incurred by the minimum days of elementary schools.
5. A contribution of \$1,000,000 to the Post-employment Benefits Fund (Fund 20) has been budgeted to reserve for the implementation of GASB 45.

RESERVE FOR ECONOMIC UNCERTAINTIES

The District budget reflects a 3% + \$2M reserve of the total General Fund budget for 2008-09.

Public Comments:

- *Harry Keiley, SMMCTA President, addressed the board regarding this item.*

The presentation can be found under Attachments at the end of these minutes.

Ms. Pye said she supported a cost-saving strategy as a means to save jobs. She asked if the attendance campaign help with ADA, if a utilities audit could find ways to save money, how the Education Foundation could help bring in additional funds. She also suggested that district examine independent consultant costs and conference and travel expenditures.

Mr. de la Torre suggested that cuts not negatively affect Special Education nor work regarding the Students of Color Task Force recommendations.

Dr. Escarce said he supported a freeze of spending on non-essential line items. Ms. Maez explained that while a freeze can be taken too literally, managers who control a budget should be required to closely monitor and scrutinize their department's or site's expenditures.

Ms. Leon-Vazquez suggested the district review the strategic plan and prioritize where funds should be spent. She also suggested hiring a grant writer for the district.

Mr. Allen commented that investing in community relations can help to raise funds through contacting alumni, potential donors, businesses; etc.

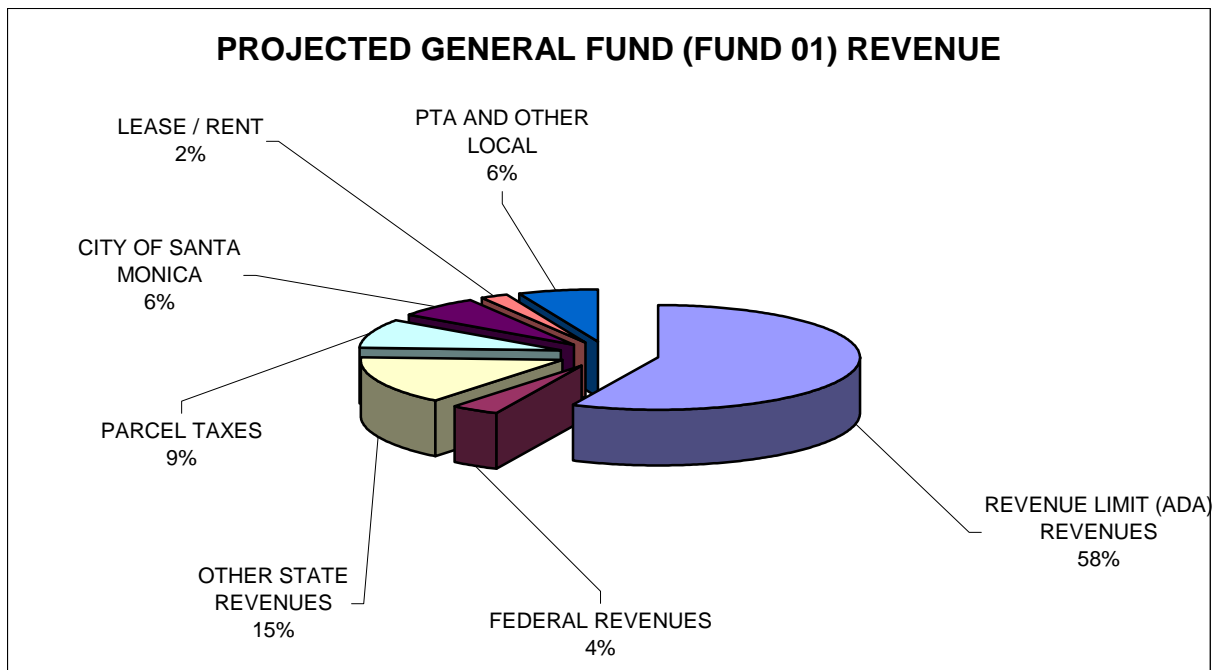

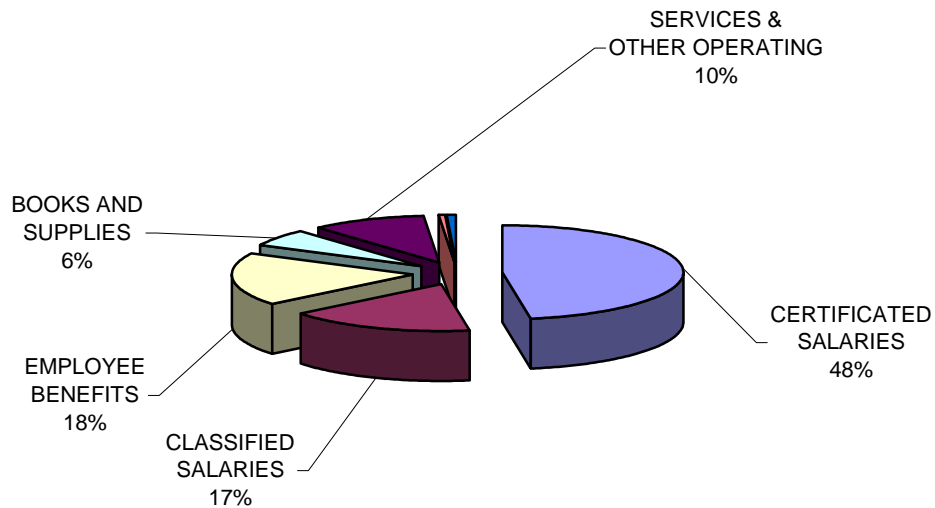

DISCUSSION ITEM NO. D.01

There are approximately 400 existing board policies, administrative regulations and exhibits in the Santa Monica - Malibu Unified School District. The Board of Education regularly has policy updates on the agenda, but there are still many policies that have not been updated. The District has had situations where a board policy should have been updated to stay current with federal law, state law, case law and/or California Education Code.

California School Board Association (CSBA) has outlined 634 policies, administrative regulations and exhibits for districts to consider. The California School Boards Association (CSBA) is a collaborative group of virtually all of the state's more than 1,000 school districts and county offices of education. CSBA provides guidance to districts throughout California, and one of their areas of expertise is in recommending board policies that are consistent with federal and state laws, and in letting district know how and when they should update those policies.

SMMUSD staff worked with CSBA personnel to update our policies. After three full days of examining current policies and CSBA-recommended policies, and more hours of reviewing those changes, district staff will be recommending a combination of District-approved policies and CSBA-recommended policies. This review process will continue through December, at which time we will send our recommendations to CSBA. CSBA will take those recommendations and provide a recommendation for an entirely updated set of board policies for SMMUSD.

CSBA's recommendation, based upon successful experiences with more than 200 districts across the state, is for the Board to (1) delete all existing policies, and (2) adopt the combined previously-approved district policies and staff-recommended CSBA policies. Staff is recommending this course of action and proposes the schedule below for accomplishing this task:

Ms Leon-Vazquez expressed her support for the collaborative and the opportunities it provides students.

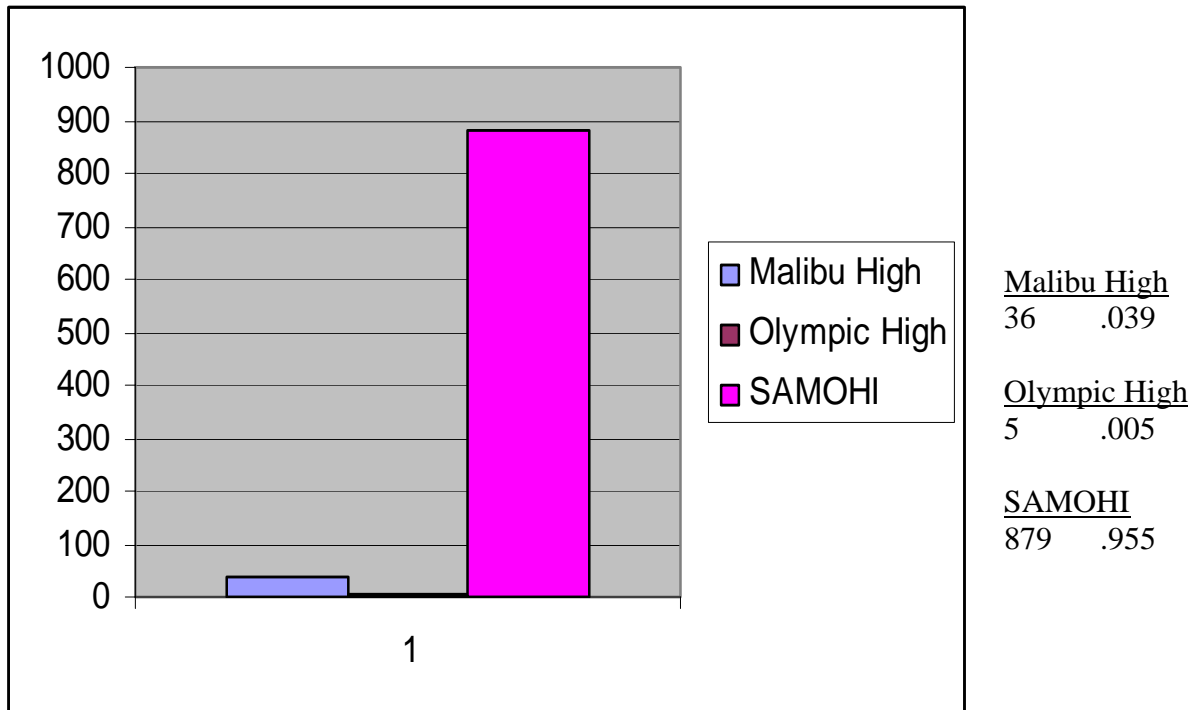

Santa Monica-Malibu Unified School District**

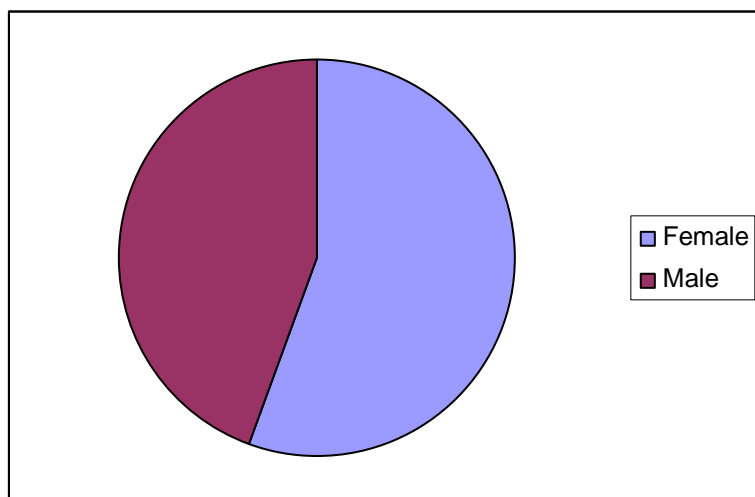

Student Enrollments by High School



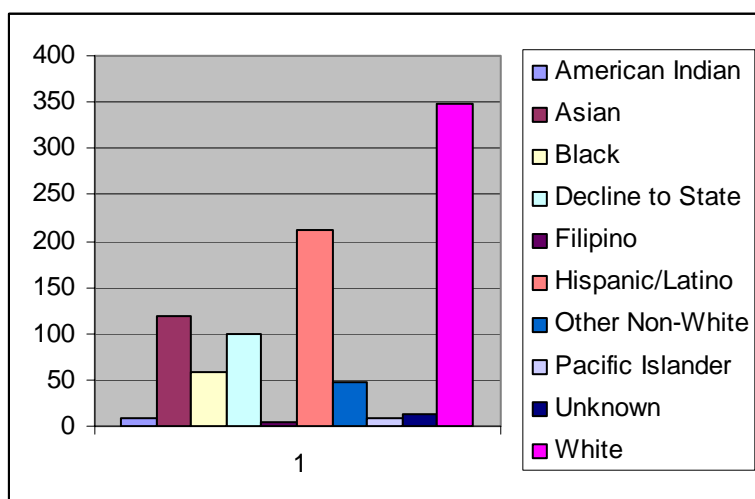

Total Student Enrollments by Gender



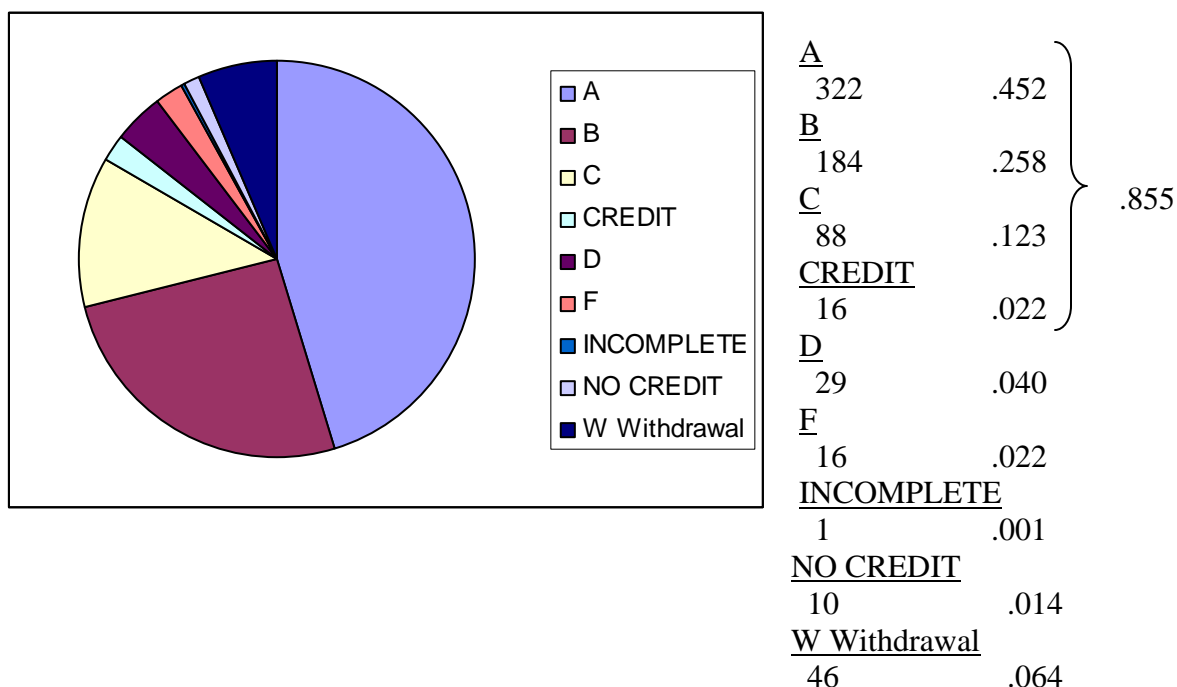

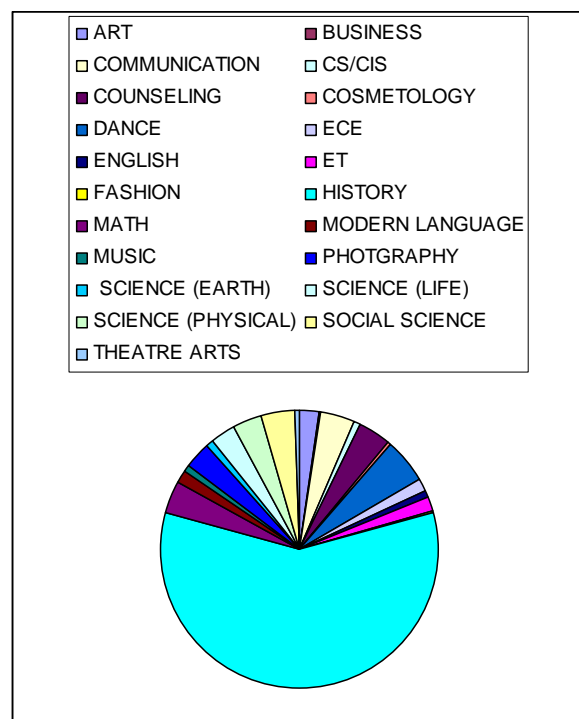
Grade Distribution

Enrollment by Department

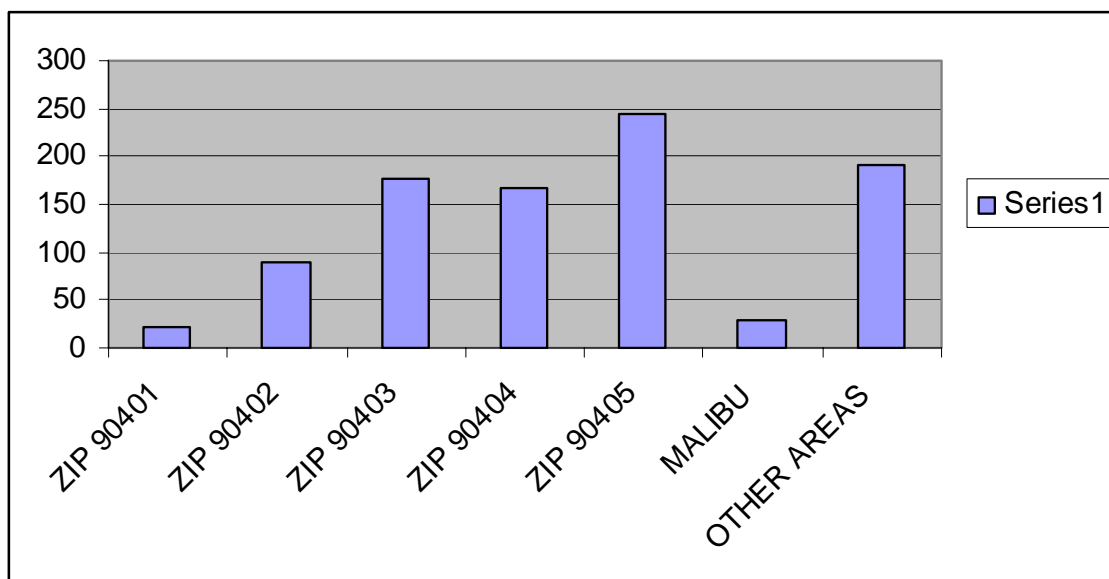

Santa Monica-Malibu Educational Collaborative

- There are 20 standing Collaborative members from both the Santa Monica-Malibu Unified School District and the Santa Monica College as well as representatives from Santa Monica-Malibu Education Foundation, UCLA, and LA County Office of Education. Both the SMMCTE and the SMC Faculty Council provide representation on the Collaborative. There are a total of 32 persons on the email list who are informed and invited to the Collaborative meetings. The Collaborative is co-chaired by Dr. Sally Chou of the District and Katharine Mueller, Dean at SMC.
- The Collaborative group serves as the planning committee for the offering of concurrent and dual enrollment courses as well as planning for other collaborative educational activities such as CAHSEE Prep and High School Diploma programs.
- The Collaborative meets once a month, generally on the second Wednesday of each month in the conference room at the Santa Monica College's Academy of Entertainment and Technology.
- The Young Collegians Program is one of the products of the Collaborative. A total of 24 students (*first generation college attendee hopefuls*) participated in Cohort 1 last summer on SMC campus taking Counseling 1 and Speech 5 classes along with other supportive workshops. Different activities are being held to continue to support these students on the Samohi campus. They will continue to take classes the next summer on SMC campus. The District is in the process of recruiting for cohort 2 students (rising sophomores).
- Through the Strengthening Grant, our teachers and staff are invited to participate in a series of conferences to learning more about the collaboration in the various programs between school districts and community colleges.
- Other activities included: a SMC sponsored field trip on September 24, 2008 to Ability Tri-Modal Transportation Services and the Long Beach Harbor to better acquaint the school district staff on the emerging career in Logistics which will be offered to our students during the Spring semester; a Counselors Day at SMC on November 12, 2008 to acquaint the counselors with the programs that are accessible to our students beyond the advanced scholastic work to include career, technical and vocational programs such as the Teacher Academy, Early Childhood Education, Nursing, Business Logistics, and Copernicus Project.

3. Recommend **how we will measure progress** so that we maintain momentum and build in the means for continuous improvement and adaptation.

The Working Group is working on and will submit recommendations to the Superintendent, who will share these recommendations with the Board in February 2009.

DETAIL

Admission

The Governing Board believes that all children should have the opportunity to receive educational services. Staff shall encourage parents/guardians to enroll all school-aged children in school.

The Superintendent or designee shall maintain procedures that provide for verification of all entrance requirements specified in law and in Board policies and regulations.

Residency

Children attending public school must attend school in the school district wherein their parent/legal guardian resides, unless explicitly authorized to attend school in another district (Education Code Section 48200, 48204). Accordingly, it is the district's policy to require valid proof of residency for all students and to be vigilant in discovering and terminating enrollment that does not comply with residency laws or meet the conditions identified in the California Education Code.

1. The Superintendent or designee is authorized to require the parent/legal guardians of students to provide to the district verifiable documentary evidence of residency, to execute affidavits attesting to residency, and to otherwise prove residency to the satisfaction of the district. Proof of residency shall, at a minimum, be required upon a student's initial enrollment in the district, whenever there is a change in residency, and at any time a student's residency with the district is in doubt.

2. Any student enrolled in the district shall immediately notify the district of any change in circumstances, which would affect their residency determination under this policy. Failure to do so shall result in disenrollment and disqualification from future enrollment under the Board's Inter-district Transfer Policy.

3. The Superintendent or designee is authorized to investigate any cases where there may be reason to believe that a student and/or parent/legal guardian does not reside with the district,

has provided false information to the district with respect to residency or where there may be reason to believe that the information provided is no longer current or accurate.

4. If the Superintendent or designee determines that a student currently enrolled in the district is not a resident of the district, the student shall be disenrolled from the district, effective the Friday of the week following the determination of nonresidency.

5. In the event the district becomes aware of any violation of law during the course of enforcing this policy, including violation of fraud or perjury statutes, the Superintendent or designee may refer such matters to the appropriate law enforcement authorities for criminal investigation.

DETAIL

The Governing Board encourages parents/guardians and other members of the community to share their time, knowledge and abilities with students. Volunteer assistance in schools enriches the educational program, enhances supervision of students and contributes to school safety while strengthening the schools' relationships with the community. The Board also encourages community members to serve as mentors providing support and motivation to students.

The Superintendent or designee shall develop and implement a plan for recruiting, screening and placing volunteers, including strategies for reaching underrepresented groups of parents/guardians and community members. He/she may also recruit community members to serve as mentors and/or make appropriate referrals to community organizations.

The Superintendent or designee shall establish procedures to protect the safety of students and adults. These procedures shall include laws related to tuberculosis testing and may also include laws related to criminal record checks.

Volunteers shall be provided with information about school goals, programs and practices and shall receive an orientation and other training related to their specific responsibilities as appropriate. Employees who supervise volunteers shall ensure that volunteers are assigned meaningful responsibilities that capitalize on their skills and expertise and maximize their contribution to the educational program.

Volunteers shall act in accordance with district policies, regulations and school rules. At their discretion, employees who supervise volunteers may ask any volunteer who violates school rules to leave the campus. Employees also may confer with the principal or designee regarding any such volunteers. The Superintendent or designee shall be responsible for investigating and resolving complaints regarding volunteers.

Volunteer maintenance work shall be limited to those projects that do not replace the normal maintenance duties of classified staff. The Board nevertheless encourages volunteers to work on short-term projects to the extent that they enhance the classroom or school, do not significantly increase maintenance workloads and comply with employee commitments and contracts.

Volunteer aides shall not be used to assist certificated staff in performing teaching or administrative responsibilities in place of regularly authorized classified employees who have been laid off. (Education Code 35021)

The Board encourages principals to develop a means for recognizing the contributions of each school's volunteers.

The Superintendent or designee shall periodically report to the Board regarding the district's volunteer assistance program.

DETAIL

Volunteers may assist certificated personnel in the performance of their duties, in the supervision of students, and in instructional tasks which, in the judgment of the certificated personnel to whom the instructional aide is assigned, may be performed by a person not licensed as a classroom teacher. These duties shall not include assignment of grades to students. (Education Code 45343, 45344, 45349) A **volunteer** will be defined as a parent, community member, or other adult who assists at a school site or program on a regular or semi-regular basis, usually with an assigned schedule. A volunteer provides his/her time to the District without pay. Individuals who are at the school to attend or help at a one-time special event involving no unsupervised contact with children are not considered volunteers.

Volunteers may supervise students during lunch and/or breakfast periods or may serve as nonteaching aides under the immediate supervision and direction of certificated personnel to perform non-instructional work which assists certificated personnel in the performance of teaching and administrative responsibilities. (Education Code 35021, 44814, 44815) Volunteers may work on short-term facilities projects pursuant to Governing Board policy and administrative regulation. Any volunteer who will be driving students must submit their driver's license and insurance and the District will examine DMV records before approval. There are two levels of volunteers:

LEVEL 1 Volunteers Working Under the Constant Direct

Supervision of a Certificated Employee

These volunteers serve during and after school hours to work in classrooms, on the campus, or in special school programs. Examples would include: lunch assistant, playground supervision, classroom aide or helper, assisting in the library, and assisting at lunch or after school club or school activity.

**LEVEL 2 Volunteers Working Under the Supervision of
Certificated Employee But Occasionally Unsupervised While
Working with Students**

Examples would include athletic coaches, performing arts
coaches, tutors and chaperones on overnight trips

Qualifications of Volunteers

Volunteers providing supervision or instruction of students pursuant to Education Code 45349 shall give evidence of basic skills proficiency. (Education Code 45344.5, 45349)
A person who is required to register as a sex offender pursuant to Penal Code 290 shall not serve as a volunteer instructional aide or as a volunteer nonteaching aide under the direct supervision of a certificated employee. (Education Code 35021)

The Superintendent or designee shall verify by reasonable means that persons serving as volunteer instructional aides and nonteaching volunteer aides are not required to register as a sex offender pursuant to Penal Code 290.

No volunteer shall be assigned to provide supervision or instruction of students unless he/she has submitted evidence of an examination within the past 60 days to determine that he/she is free of active tuberculosis. Volunteers who skin test negative shall thereafter be required to take a tuberculosis test every four years in accordance with Education Code 49406. (Education Code 45106, 45347, 45349, 49406.

The Superintendent or designee may exempt from tuberculosis testing requirements those volunteers who serve less than a school year and whose functions do not require frequent or prolonged contact with students. (Education Code 49406)
Volunteers engaged in the performance of any service to the District are considered an employee of the District for the purpose of Workers' Compensation Insurance.

The School Site is responsible for receiving, approving and maintaining Level 1 volunteer applications. Level 2 applications must be approved by the Assistant Superintendent, Human Resources after fingerprint clearance. The District will continue to provide TB testing and cover the cost (about \$5) for volunteers. If a chest x-ray is required, the District does not provide that service and will not cover that cost. The District will cover the cost of fingerprinting (about \$50). Any volunteers who would like to make a donation to cover those costs may certainly do so.

The Special Education Collaborative: Update on the Working Group

The Working Group

Overarching Goals:

- 1.Recommend **strategic priorities** to the Superintendent for strengthening and improving the quality and culture of Special Education.
- 2.Describe what it will take to ensure a collaborative and constructive partnership between the district and the community: the **critical factors for successful implementation**: roles, decision rights, processes, and resource investment.
- 3.Recommend **how we will measure progress** so that we maintain momentum and build in the means for continuous improvement and adaptation.

The Working Group is working on and will submit recommendations to the Superintendent, who will share these recommendations with the Board in February 2009.

Progress to Date:

First Meeting:

Group Formation: The work of formation was to build a foundation of trust through a shared vision, agreements, and experiences.

We were able to:

- Agree upon a charter
- Agree on our rules of engagement: principles and practice
- Develop a "Disciplined Message" about communicating with key stakeholder groups
- Develop questions for informational briefings regarding Human Resources, Programs, and Finances
- Schedule our next meeting

Progress to Date:

Second Meeting:

Created a Common Understanding of what has happened:

By the end of this meeting we were able to:

- Continue to build the agreements and processes our working group will need to be successful
- Develop a common baseline understanding of past efforts and the thinking behind the recommendations (Weintraub, Atlas, Strategic Plan, and the Barber Report)
- Schedule our next meeting

Observations & Concerns

- While we understand that the work ahead will be difficult and that significant change will take time, we are encouraged by the support of the District. We have experienced the spirit of collaboration in our Working Group meetings.
- By reviewing and discussing the three Reports created since 2000 and the Special Ed Strategic Plan, we now have a shared historical understanding of SMMUSD Special Education reports.
- We feel like we have broken some barriers to transparency by making the reports available to the Working Group and talking about them openly.
- We are in the process of compiling program and financial briefings and specific answers to our questions of November 14th, that will allow us to evaluate and prioritize various issues and strategies and inform our priority setting.

Observations & Concerns

- After a historical review all the Reports we see that certain patterns have emerged: lack of implementation of recommendations, lack of communication regarding implementation, lack of ownership, and leadership turnover at a high level.
- Communication seems to be an area of concern both between the district office staff, the district and school sites, and between the district and parents.
- We identified that a necessary component of success is accountability at all levels beginning with the Superintendent.

Next Steps

We will be meeting December 12 from 1-6pm.

- We will receive program and financial information and specific answers to our questions of November 14th.
- Drawing on past work and informed by program and financial information that will be provided to us in writing, we will work on developing a set of **prioritized recommendations**.
- We will also begin work on identifying **critical factors for implementation**: what it will take to assure follow through and impact.



Santa Monica Pier Centennial

'100 Years in the Past, 100 Years in the Future'

Curriculum, Activity Plans and Opportunities for Youth Involvement

History of the Pier

Students learn about the history of the pier from its christening in 1909 to the present.

Activities - Walking history tour, creation of Pier timeline, Pier Fashion through the decades.

Architecture of the Pier

Students learn about how the Pier was designed and built.

Activities - Kids talk with architects and construction workers who rebuilt the Pier after the 1983 storms, kids create their own Pier models.

Pier Art

Students learn about the art and artisans of the Pier.

Activities - Kids learn about plein air painting and select something on the Pier to paint, 3-dimensional art mediums, possibly culminating in an art show.

Pacific Park

Students learn about the physics of amusement park rides, probability and winning at carnival games and how the sun powers the Ferris wheel.

Activities - Kids visit Pacific Park on spring break.

Recreation and Fitness on the Pier

Students learn about fitness and health and the importance of preserving parks, open spaces for recreation.

Activities - Kids skate, bike or walk to the Pier and track distance traveled, heart rate, calculate calories of foods served on the Pier etc.,

Safety and Security on the Pier

Students learn about what it takes to keep the Pier and the people who visit the Pier safe.

Activities - Visit to the SMPD Pier Substation, visit Harbor Patrol and observe an ocean rescue.

Santa Monica Pier Aquarium

Students learn about natural history and the environment, including sea and beach life surrounding the Pier.

Activities - Kids visit the Aquarium, learn about Heal the Bay, participate in a Beach Clean-Up Day.

Future of the Pier

Students think about the future of the Pier 100 years from now and discuss the importance of preservation.

Activities - Kids create items for a time capsule, kids write letters to kids in the future, kids draw pictures of the Pier and the surrounding city in the future.
