A. Student Board Member Reports (15)

Tanya Choo – Santa Monica High School

Student Board Member Choo reported that the Samohi drumline placed second overall in its competition this past Saturday. They won awards for best tenorline and best bassline. The track finals occurred today; they were successful against Culver at the preliminary round. All spring sports are finishing league and will soon begin CIF. AP testing started this week and continues through next week, while CST testing is from May 16-20. ASB organized a Club Day during which several clubs participated in selling food to students as a fundraiser. There was a Cinco de Mayo celebration in the quad today celebrating the culture, music, and food of Mexico. ASB is working on a CST Testing Campaign that aims to motivate students to reach an API score of 800+. The ASB elections for the Executive Cabinet went very smoothly last week. The senior prom is on May 14. Several film students participated in and won awards at the Santa Monica Teen Film Festival. Awards won by Samohi students included the Budding Filmmaker Award, the Viewers' Choice Award, and the Best of Festival Award. Senior Commit Day was on May 2; students wore the gear of the college they will be attending in the fall.

In response to Mr. Allen's inquiry, Ms. Choo reported that Hunter Conrad will be the new Student Body President. The new Student Board Member will be Caroline Huber. Mr. Allen asked Ms. Choo to help Ms. Hoover prepare for her job.

Student Board Member Wilson reported that AP testing was underway. Tomorrow, the middle school will be hosting a glow-in-the-dark dance, and there will be an In'n'Out truck on campus from 5:30-7:00pm. The Boys and Girls Club is having its ten-year anniversary event on Saturday. Over spring break, the varsity cheerleading squad attended a National Cheerleading Competition hosted by Sharp International in Las Vegas. They took home first place in their division. 190 parents completed the middle school parent survey, the findings of which will be summarized and used to improve programs and practices aimed at making sure the district's students are healthy, safe, engaged, supported, and challenged academically. The high school musical Evita will be showing June 2-4. Malibu High School's 7th Annual Operation Smile fundraiser will be this Saturday from 7:00-9:00pm. The equestrian team finished fifth place overall in the team standings; three varsity members finished twelfth out of thirty-one in their division. The eighth grade exit exam interviews will be May 16-19; Ms. Wilson thanked Ms. Leon-Vazquez and Ms. Lieberman for volunteering.

Ms. Cartee-McNeely reported that last Tuesday, she and Ms. Jones attended a bargaining unit meeting regarding the permits program. They have requested a meeting with the district to discuss the potential impact on the bargaining members. Ms. Cartee-McNeely brought the board's attention to Item No. A.27, saying it was a wonderful recognition of classified employees and their valuable contributions to district. She invited the board to a reception being hosted by the personal commission on May 10 at 4:00pm in the board room.

D. PTA Council – Shari Davis (5)

Ms. Davis expressed the parents' appreciation for the district's dedicated teachers and classified staff. She announced that in a show of solidarity with teachers and classified staff, the PTA will be participating in the state PTA's upcoming Week of Action regarding the state's budget crisis. Activities include the Cut\$ Hurt Kids Campaign, spreading the word via Facebook, and asking members to advocate for school funding (visit www.capta.org). At the last PTA Council meeting, the members reviewed the PTA priorities, and the council continues to work with the district on the middle school initiative. They are preparing for the transition of PTA officers, who assume their responsibilities on June 1. Tuesday morning is the installation breakfast from 9:00-11:00am. PTA continues to work with the Education Foundation, the City of Santa Monica, and the Chamber of Commerce to develop Buy Local strategies. Summer Adventure registration is going strong; they look forward to having the kids do great things during the summer. As the district enters the final six weeks of school, the PTA would like to thank everyone who works so hard, including staff and parents.

X. SUPERINTENDENT'S REPORT (5)

Superintendent Cuneo reported that three open houses were held last week for the unveiling of the Strategic Plan draft framework. Participants given an overview of the Strategic Plan and then broke out into smaller groups to examine potential action steps to implement the plan. Staff will now incorporate this feedback into the presentation to the board.

Last Saturday, the district continued its work on the middle school initiative, focusing on five tenants of the whole child. They reviewed the initial student, parent, and staff survey data, and began putting together action steps for presentation to the board. Mr. Cuneo said the initiative aligns perfectly with the Strategic Plan draft framework.

Pre-K and Kindergarten transition meetings, convened by Dr. Chou last week, focused on improving the transition for students. He commended the Ed Services Department for their work on this goal.

In an audit conducted by the CA Department of Education, the district's Food and Nutrition Services Department was found to be in compliance. Mr. Cuneo said he was very proud of that department for finishing a great audit.

Ms. Lieberman asked about the Samohi Principal search. Mr. Cuneo reported that the first round of interviews would be on May 20, with the second round the next day or early the following week. The new superintendent will be involved in the second round. Background checks and site visits will then be conducted. A recommendation will most likely be brought to the board on June 2. Ms. Choo asked how many people have applied. Mr. Cuneo said he did not have that information, but remarked that the district often attracts a good number of candidates.

This project will address the damage to the underground gas lines that are currently leaking. The site has no gas at this time for heating and cooking. Portable electric heaters have been purchased in the interim at a high cost of fuel, to provide heat to classrooms on the colder mornings. All gas cooking and food preparation has ceased in the cafeteria. The total scope of work will be determined after the contractor has completed inspection of the facility. It is anticipated that the cost will not be over \$100,000 and can be completed in two-three weeks if the method of either sealing the pipes from the inside or sleeving the pipes and seals will work. Work can be completed with the trenching causing no disruption to the facility, and would allow the district to return to the more efficient gas heat. Should the issues be deemed more involved than originally anticipated, with engineering and DSA review is required, the project will be taken through proper bidding procedures.

This emergency procedure will enable the District to correct this condition by June 2011 (2-3 weeks from award of contract) at Webster Elementary School.

The estimated cost of this job is \$100,000.

BE IT FURTHER RESOLVED that this Board makes contracts in writing on behalf of the District, without advertising for bids or inviting of bids for the performance of labor and furnishing of materials and supplies for such repairs, alterations, work and improvements.

COMMENTS: District staff has been researching technology upgrades and enhancements to meet various district needs over the past several years. The Measure BB bond program has provided many technology upgrades both in the classroom and as infrastructure for a robust network which provides a backbone to support various applications as needs are identified. With the implementation of a Cisco Telepresence solution, the various District needs listed below will be addressed.

Teaching between Santa Monica and Malibu High School Sites

Background: Currently, classes can not be offered at various campuses due to low attendance or interest in the class/subject matter.

Application: The need for several High School students to hear the teacher lecture and hear comments from students in classroom. The need for the High School students to participate in classroom discussions and for the students and teacher to hear the comments in the other location.

Teaching between Sites – College, High School Classes

Background: High School Students are taking SMC classes and need to drive to the college to attend classes.

Application: The need for several High School students to hear the college teacher lecture and hear comments from students in classroom. The need for the High School students to participate in classroom discussions and for the college students and teacher to hear the comments.

Management Meetings

Background: Currently the management team meets in Santa Monica at various locations. Individuals working/living in Malibu must drive to these meetings.

Application: Provide access between Malibu and Santa Monica for Management Meetings

Environment: Malibu Administration staff would be able to attend meetings by gathering at Malibu High School. Santa Monica Administration staff would be able to attend Malibu meetings by gathering at either the District office or Santa Monica High School. Each school site has a minimum of one Principal and one Asst Principal who would attend meetings (Approx. 40-50 administrative staff total).

Staff/Administration Meetings

Background: Currently Administrators drive between Malibu and Santa Monica for various meetings, comprised of one-on-one or several people from a department depending on topic. Meeting duration could be ½ hr to 1 hour or more, with a minimum of 1.5 hrs spent in travel time.

Application: The need for one speaker to speak to another in an off-site location, or several individuals speaking to one or more speakers at another location.

Bids were sent to contractors. Only one supplier provided a proposal. Due to the uniqueness of the equipment and certification requirement for this type of installation, only a few suppliers are able to bid this type of equipment. District staff has reviewed the bid submittal along with the District's technology consultant, and have determined that the bid is under budget, and provides for all requested equipment and training necessary to implement the project.

Mr. Mechur asked what equipment would be purchased. Dr. Chou said the district would be purchasing large, flat-screen TVs with cameras and stands, software, and content servers. There will be one set at the district office, one at Samohi, and one at Malibu HS. This will allow for live discussions between the two cites, enabling staff to communicate without traveling and students at one high school to take classes being offered at the other school, such as Calculus DE. Dr. Chou added that this technology could also serve to allow individuals to remotely "attend" board and committee meetings.

It is recommended that the Board of Education hold a public hearing on the matter of the Special Parcel Tax (Measure R) regarding applying a Consumer Price Index (CPI-U) adjustment. The hearing is scheduled for Thursday, May 5, 2011, at 7:00 p.m.

COMMENT: CPI-U Adjustment: Section 4. of Resolution 07-09, *Resolution Proposing a Renewal of Special Taxes to Be Placed on the February 4, 2008 Ballot for Voter Approval* requires that: "Prior to levying of the special tax each fiscal year, the Board shall conduct a public hearing on the matter. Notice of the time, date and place of hearing shall be published in accordance with applicable laws, posted at least twice in a newspaper of general circulation in the District, and posting shall commence at least fifteen (15) days prior to the hearing. Following said hearing each year, the Board shall adopt a resolution establishing the rate per parcel for that year, not to exceed \$346.00 per year adjusted annually for inflation by the CPI-U. "CPI-U" as used in this Resolution means the Consumer Price Index-All Urban Consumers, All Items for the Los Angeles-Riverside-Orange County, California Metropolitan Statistic Area, base period 1982-84=100, or its equivalent should this Index cease to exist in its current format. The annual CPI-U adjustment shall be based on the change in the CPI-U over the preceding fiscal year. Any tax levied shall become a lien upon the properties against which taxes are assessed and collectable as herein provided;"

According to *The Santa Monica-Malibu Schools Quality Education Funding Renewal Measure* Section 4.A, THE TAX LEVY-Tax Base, "The annual CPI-U adjustment shall be the twelve (12) month change in that index over the most recently available twelve (12) month period preceding the date on which the adjustment needs to be calculated for assessment purposes." Subsequent to the Public Hearing, the Board of Education will formally consider the adoption of a \$358.91 per parcel assessment for 2011-12 (2.3% increase from the current \$350.84 per parcel rate based on the change in the CPI-U between February 2010 and February 2011).

Notice of the public hearing has been properly posted as required by Government Code §6061 in *The Santa Monica Daily Press* and *The Malibu Surfside News*.



It is recommended that the Board of Education approve the proposed application for additional funding/program to serve students in poverty within Child Development Services (CDS).

Comment: A local Head Start/State Preschool program is ceasing operations as of July 30, 2011. Both the Child Development Department of the State Department of Education and Los Angeles County Office of Education (LACOE) representing the federal government are seeking an agency to take over the program operations for children from the Santa Monica and Venice areas. An opportunity to serve the children from the program would expand the preschool services offered by Child Development Services and would decrease the number of FTE's in the proposed staff reduction caused by the State funding reductions.

The program serves preschool children ages 3 and 4 from families living in poverty. The program operates 6.5 hours per day for 200 days in a school year. Three hours of the day are funded by State Preschool funds. Three and a half hours are funded by Federal Head Start funds.

CDS is responding to the Request for Application (RFA) from LACOE to request funds to serve approximately 120 Head Start children, and has confirmed with the State Department of Education that there is additional State funding available to CDS to operate the state portion of the day for the same children.

The 75 page application document must include a signed document from the President of the School Board. CDS requests board approval to apply for the additional funds.

Mr. Mechur asked how many more children would be entering our system from these outside programs. Ms. Abdo said it would be approximately 120. According to the proposal and requirements from LACOE, children from two of the four sites would be brought to existing CDS sites while the remaining two sites would remain where they are.

During this discussion item, staff will make a presentation for a proposed 2011-12 service plan for Child Development Services and demonstrate how the changes affect current organizational structure.

The District has received information regarding the funding changes in Child Development Services: 15% reduction of contract amounts; the reduction of eligibility from 75% of state median income to 70%; the ineligibility for 11- and 12-year-olds to receive subsidy for childcare; and an increase of 10% in family fees based on sliding scale.

Therefore, Child Development Services will adjust its program services to meet the fiscal and operational challenges of reductions in state programs and contracts by reorganizing its services to families in the District.

Staff recommends that this item return for action at the May 19, 2011, board meeting.

The presentation can be found under Attachments at the end of these minutes. Ms. Abdo emphasized the close relationship the district has with the City of Santa Monica.

Ms. Abdo outlined the cost to families for each of the programs, as well as how the programs are funded.

Mr. Allen asked about recruiting more full-fee families to the district's preschool programs. Ms. Abdo said the district is examining that option, but the space is limited for licensed preschool classrooms, which are set up based on ages of the children served; the current set up could not be augmented for a full-day, full-fee program by this September without funds. Mr. Allen asked about the former Washington West building. Ms. Maez and Ms. Abdo explained that Measure BB funds have been earmarked for Washington West and East, but they do not include the abandoned building Mr. Allen mentioned.

Mr. Allen tasked CDS and the Early Child Care DAC with examining the expansion of a full-fee program. The board agreed. This reorganizational item will return for action at the May 19, 2011, board meeting.

The Board believes that commending such service promotes increased community understanding and participation.

~~The Superintendent or designee shall establish procedures by which Board members, employees or members of the community may suggest persons or organizations for Board recognition. At the Board's discretion, letters of recognition, Board resolutions, plaques or awards may be presented.~~

Any Board member, employee, parent/guardian, student, or community member may recommend an individual or organization for Board recognition. He/she shall submit to the Superintendent or designee the name of the individual or organization and a description of the outstanding contribution or service.

At the Board's discretion, the Board may present a letter of recognition, Board resolution, plaque, or other award at a public Board meeting or may hold a reception or informal recognition activity. The Board also may designate a day, week, or month for special recognition of volunteers.

It is recommended that the Board of Education consider revising BP 1240 – Volunteer Assistance.

COMMENT: CSBA is recommending this policy update to reflect new law (AB 346), which requires any volunteer who works with students in a student activity program (not just those who supervise, direct, or coach the activity) to obtain an Activity Supervisor Clearance Certificate from the Commission on Teacher Credentialing (CTC), unless the district requires the volunteer to instead clear a Department of Justice (DOJ) and Federal Bureau of Investigation (FBI) criminal background check or the volunteer is otherwise exempted by law.

The revised policy is attached.

This item will return for approval at the May 19, 2011, board meeting.

VOLUNTEER ASSISTANCE

The Board of Education encourages parents/guardians and other members of the community to share their time, knowledge and abilities with students. Volunteer assistance in schools enriches the educational program, enhances supervision of students and contributes to school safety while strengthening the schools' relationships with the community. The Board also encourages community members to ~~serve as mentors providing support and motivation to students~~ share their time, knowledge, and abilities with students.

The Superintendent or designee shall develop and implement a plan for recruiting, screening and placing volunteers, including strategies for reaching underrepresented groups of parents/guardians and community members. He/she may also recruit community members to serve as mentors and/or make appropriate referrals to community organizations.

The Superintendent or designee shall establish procedures to protect the safety of students and adults. These procedures shall include laws related to tuberculosis testing and may also include laws related to criminal record checks.

Volunteers shall be provided with information about school goals, programs and practices and shall receive an orientation and other training related to their specific responsibilities as appropriate. Employees who supervise volunteers shall ensure that volunteers are assigned meaningful responsibilities that capitalize on their skills and expertise and maximize their contribution to the educational program.

Volunteers shall act in accordance with district policies, regulations and school rules. At their discretion, employees who supervise volunteers may ask any volunteer who violates school rules to leave the campus. Employees also may confer with the principal or designee regarding any such volunteers. The Superintendent or designee shall be responsible for investigating and resolving complaints regarding volunteers.

Volunteer maintenance work shall be limited to those projects that do not replace the normal maintenance duties of classified staff. The Board nevertheless encourages volunteers to work on short-term projects to the extent that they enhance the classroom or school, do not significantly increase maintenance workloads and comply with employee commitments and contracts.

Volunteer aides shall not be used to assist certificated staff in performing teaching or administrative responsibilities in place of regularly authorized classified employees who have been laid off. (Education Code [35021](#))

The Board encourages principals to develop a means for recognizing the contributions of each school's volunteers.

Volunteers shall act in accordance with district policies, regulations, and school rules. The Superintendent or designee shall be responsible for investigating and resolving complaints regarding volunteers.

The Superintendent or designee shall periodically report to the Board regarding the district's volunteer assistance program.

Prior to assuming a volunteer position to work with students in a district-sponsored student activity program, a volunteer shall possess an Activity Supervisor Clearance Certificate issued by the Commission on Teacher Credentialing. (Education Code 49024)

A volunteer who obtained both a Department of Justice and Federal Bureau of Investigation criminal background clearance through the district prior to July 9, 2010, shall have satisfied this requirement. (Education Code 49024)

It is recommended that the Board of Education consider revising BP 1250 – Visitors/Outsiders.

COMMENT: CSBA is recommending this policy update to encourage individuals to use complaint procedures and to avoid disruptive behavior on school grounds.

The revised policy is attached. (Revisions to the AR can be found under Information Items.)

VISITORS/OUTSIDERS

The Board of Education encourages parents/guardians and interested members of the community to visit the schools and view the educational program.

To ensure the safety of students and staff and minimum interruption of the instructional program, the Superintendent or designee shall establish procedures which facilitate visits during regular school days. Visits during school hours should be first arranged with the ~~teacher and~~ principal or designee. If a conference is desired, an appointment should be set with the teacher during noninstructional time.

~~To ensure the safety of students and staff and avoid potential disruptions, all visitors~~ Any person who is not a student or staff member shall register immediately upon entering any school building or grounds when school is in session.

~~For purposes of school safety and security, the~~ The principal or designee may design a visible means of identification for visitors all individuals who are not students or staff members while on school premises.

No electronic listening or recording device may be used by students or visitors in a classroom without the teacher and principal's permission. (Education Code [51512](#))

The Board encourages all individuals to assist in maintaining a safe and secure school environment by behaving in an orderly manner while on school grounds and by utilizing the district's complaint processes if they have concerns with any district program or employee. In accordance with Penal Code 626.7, the principal or designee may request that any individual who is causing a disruption, including exhibiting volatile, hostile, aggressive, or offensive behavior, immediately leave school grounds.

DISCUSSION ITEM NO. D.06

It is recommended that the Board of Education consider revising BP 6011 – Academic Standards.

COMMENT: CSBA is recommending this policy update to reflect the State Board of Education's adoption of the Common Core Standards, a set of national voluntary standards in English language arts and mathematics. The policy also adds language regarding (1) involvement of representatives of businesses and postsecondary institutions in the recommendation of district standards; (2) alignment of standards with graduation requirements, college entrance requirements, and other student outcomes; and (3) review of standards in response to changing student needs.

The revised policy is attached.

This item will return for approval at the May 19, 2011, board meeting.

ACADEMIC STANDARDS

The Board of Education shall adopt high academic standards for student achievement which challenge all students to reach their full potential and which clarify what students are expected to know and be able to do at each grade level and in each area of study. These standards shall reflect the knowledge and skills needed for students to be adequately prepared for postsecondary education, employment, and responsible citizenship.

The Superintendent or designee shall provide the Board with recommended standards. In developing these recommended standards, the Superintendent or designee shall use a process that involves teachers, school site and district administrators, students, parents/guardians, and community members. He/she shall ensure the alignment of the standards with the district's vision and goals, graduation requirements, college entrance requirements, and other desired student outcomes, and ~~ensure the~~ proper articulation of standards between grade levels. He/she also shall ensure that the standards are easily understandable and measureable.

District content standards for English language arts, English language development, mathematics, science, health education, history-social science, physical education, visual and performing arts, world languages, career technical education, and preschool education shall meet or exceed statewide model content standards adopted by the State Board of Education or the State Superintendent of Public Instruction as applicable.

Teachers and school administrators shall receive professional development to ensure their understanding of the standards and to discuss effective instructional methods in preparing students to meet the standards.

The Superintendent or designee shall annually communicate the applicable standards to students and their parents/guardians to inform them of the expectations for student learning at their grade level.

Staff shall continually assess students' progress toward meeting the standards, report each student's progress to the student and his/her parents/guardians, and offer remedial assistance in accordance with Board policy and administrative regulation.

District standards shall also provide a basis for evaluating the instructional program, making decisions about curriculum and assessment, and, in accordance with Education Code 44662, evaluating teacher performance.

The Superintendent or designee shall ensure that district standards are regularly reviewed and updated as necessary. At a minimum, district standards shall be reviewed whenever applicable statewide standards are revised and whenever data on student achievement demonstrate that students are not adequately achieving the standards in a particular grade level or subject area.

DISCUSSION ITEM NO. D.07

It is recommended that the Board of Education consider revising BP 6161.1 – Selection and Evaluation of Instructional Materials.

COMMENT: CSBA is recommending this policy update to reflect new law (AB 2211), which revises the definition of "sufficiency of instructional materials" to include materials in a digital format as long as specified conditions are met.

The revised policy is attached. (Revisions to the AR can be found under Information Items.)

This item will return for approval at the May 19, 2011, board meeting.

SELECTION AND EVALUATION OF INSTRUCTIONAL MATERIALS

The Board of Education desires that district instructional materials, as a whole, present a broad spectrum of knowledge and viewpoints, reflect the diversity of our society, and enhance the use of multiple teaching strategies and technologies. The Board shall adopt instructional materials based on a determination that such materials are aligned with the state content standards, meet other criteria specified in law, and are an effective learning resource to help students achieve grade-level competency and meet criteria specified in law.

To ensure that instructional materials effectively support the district's adopted courses of study, the selection of textbooks, technology-based materials, other educational materials, and tests shall be aligned with the development and evaluation of the district's curriculum and standards.

The Superintendent or designee shall establish a process by which instructional materials shall be reviewed for recommendation to the Board. This process shall involve teachers in a substantial manner and shall also encourage the participation of parents/guardians and community members.

All recommended instructional materials shall be available for public inspection at the district office.

Individuals who participate in selecting and evaluating instructional materials shall not have a conflict of interest in the materials being reviewed, as defined in administrative regulation.

Complaints concerning instructional materials shall be handled in accordance with law, Board policy, and administrative regulation.

The Board's priority in the selection of instructional materials is to ensure that all students in grades K-12 are provided with instructional materials that are aligned to state content standards in the core curriculum areas of reading/language arts, mathematics, science, and history/social science. Students in grades K-8 shall be provided with instructional materials adopted by the State Board of Education.

The district may pilot instructional materials, using a representative sample of classrooms for a specified period of time during a school year, in order to determine how well the materials support the district's curricular goals and academic standards. Feedback from teachers piloting the materials shall be made available to the Board before the materials are adopted.

Public Hearing on Sufficiency of Instructional Materials

The Board shall annually conduct one or more public hearings on the sufficiency of the district's instructional materials. The hearing shall be held on or before the end of the eighth week from the first day students attend school for that year. (Education Code 60119)

The Board encourages participation by parents/guardians, teachers, interested community members, and bargaining unit leaders at the hearing. The Superintendent or designee shall post, 10 days prior to the hearing and in three public places within the district, a notice containing the time, place, and purpose of the hearing. The hearing shall not take place during or immediately following school hours. (Education Code 60119)

At the hearing(s), the Board shall determine, through a resolution, whether each student in each school has sufficient textbooks and/or instructional materials that are aligned to the state content standards adopted pursuant to Education Code 60605 in each of the following subjects: (Education Code 60119)

1. Mathematics
2. Science
3. History/social science
4. English language arts, including the English language development component of an adopted program

The Board shall also make a written determination as to whether each student enrolled in a foreign language or health course has sufficient textbooks or instructional materials that are consistent with the content and cycles of the state curriculum frameworks. The Board shall determine the availability of science laboratory equipment, as applicable to science laboratory courses offered in grades 9-12. (Education Code 60119)

In making these determinations, the Board shall consider whether each student has sufficient textbooks and/or instructional materials to use in class and to take home. However, this does not require that each student have two sets of materials. The materials may be in digital format as long as each student, at minimum, has and can access the same materials in the class and to take home as all other students in the same class or course in the district and has the ability to use and access them at home. However, the materials shall not be considered sufficient if they are photocopied sheets from only a portion of a textbook or instructional materials copied to address a shortage. (Education Code 60119)

For the 2008-09 through 2012-13 fiscal years, the Board shall also make a determination that all students within the district who are enrolled in the same course have "identical" standards-aligned textbooks or instructional materials from the same adoption cycle, as defined in Education Code 1240.3, 60119, and 60422. (Education Code 1240.3, 42605)

If the Board determines that there are insufficient textbooks and/or instructional materials, the Board shall provide information to classroom teachers and to the public, setting forth for each school in which an insufficiency exists, the percentage of students who lack sufficient standards-aligned textbooks or instructional materials in each subject area, and the reasons that each student does not have sufficient textbooks and/or instructional materials. The Board shall take any action, except an action that would require reimbursement by the Commission of State Mandates, to ensure that each student has sufficient materials within two months of the beginning of the school year in which the determination is made. (Education Code 60119)

DISCUSSION ITEM NO. D.08

It is recommended that the Board of Education consider revising BP 9270 – Conflict of Interest.

COMMENT: CSBA is recommending this mandated bylaws update to reorganize and clarify three types of analysis that must be conducted pursuant to different statutes and the common law doctrine to determine whether a conflict exists and, if so, whether the board member must abstain and/or if the contract is prohibited.

The revised policy is attached.

This item will return for approval at the May 19, 2011, board meeting.

CONFLICT OF INTEREST

The Governing Board desires to maintain the highest ethical standards and help ensure that decisions are made in the best interest of the district and the public. In accordance with law, Board members and designated employees shall disclose any conflict of interest and, as necessary, shall abstain from participating in the decision.

The Board shall adopt a resolution that specifies the terms of the district's conflict of interest code, the district's designated positions, and the disclosure categories required for each position.

Upon direction by the code reviewing body, the Board shall review the district's conflict of interest code and submit any changes to the code reviewing body.

When a change in the district's conflict of interest code is necessitated due to changed circumstances, such as the creation of new designated positions, changes to the duties assigned to existing positions, amendments, or revisions, the amended code shall be submitted to the code reviewing body within 90 days. (Government Code 87306)

When reviewing and preparing the district's conflict of interest code, the Superintendent or designee shall provide officers, employees, consultants, and members of the community adequate notice and a fair opportunity to present their views. (Government Code 87311)

Board members and designated employees shall annually file a Statement of Economic Interest/Form 700 in accordance with the disclosure categories specified in the district's conflict of interest code. A Board member who leaves office or a designated employee who leaves district employment shall, within 30 days, file a revised statement covering the period of time between the closing date of the last statement and the date of leaving office or district employment. (Government Code 87302, 87500)

Conflict of Interest under the Political Reform Act

A Board member or designated employee shall not make, participate in making, or in any way use or attempt to use his/her official position to influence a governmental decision in which he/she knows or has reason to know that he/she has a disqualifying conflict of interest. A conflict of interest exists if the decision will have a "reasonably foreseeable material financial effect" on one or more of the Board member's or designated employee's "economic interests," unless the effect is indistinguishable from the effect on the public generally or the Board member's or designated employee's participation is legally required. (Government Code 87100, 87101, 87103; 2 CCR 18700-18709)

A Board member or designated employee makes a governmental decision when, acting within the authority of his/her office or position, he/she votes on a matter, appoints a person, obligates or commits the district to any course of action, or enters into any contractual agreement on behalf of the district. (2 CCR 18702.1)

A Board member who has a disqualifying conflict of interest on an agenda item that will be heard in an open meeting of the Board shall abstain from voting on the matter. He/she may remain on the dais, but his/her presence shall not be counted towards achieving a quorum for that matter. A Board member with a disqualifying conflict of interest shall not be present during a closed session meeting of the Board when the decision is considered and shall not obtain or review a recording or any other nonpublic information regarding the issue. (2 CCR 18702.1)

Additional Requirements for Boards that Manage Public Investments

A Board member who manages public investments pursuant to Government Code 87200 and who has a financial interest in a decision shall, upon identifying a conflict or potential conflict of interest and immediately prior to the consideration of the matter, do all of the following: (Government Code 87105; 2 CCR 18702.5)

1. Publicly identify each financial interest that gives rise to the conflict or potential conflict of interest in detail sufficient to be understood by the public, except that disclosure of the exact street address of a residence is not required.
2. Recuse himself/herself from discussing and voting on the matter, or otherwise acting in violation of Government Code 87100. The Board member shall not be counted toward achieving a quorum while the item is discussed.

However, the Board member may speak on the issue during the time that the general public speaks on it and may leave the dais to speak from the same area as members of the public. He/she may listen to the public discussion of the matter with members of the public.

3. Leave the room until after the discussion, vote, and any other disposition of the matter is concluded, unless the matter has been placed on the portion of the agenda reserved for uncontested matters.

If the item is on the consent calendar, the Board member must recuse himself/herself from discussing or voting on that matter, but the Board member is not required to leave the room during consideration of the consent calendar.

4. If the Board's decision is made during closed session, disclose his/her interest orally during the open session preceding the closed session. This disclosure shall be limited to a declaration that his/her recusal is because of a conflict of interest pursuant to Government Code 87100. He/she shall not be present when the item is considered in closed session and shall not knowingly obtain or review a recording or any other nonpublic information regarding the Board's decision.

Conflict of Interest under Government Code 1090

Board members, employees, or district consultants shall not be financially interested in any contract made by the Board on behalf of the district, including in the development, preliminary discussions, negotiations, compromises, planning, reasoning, and specifications and solicitations for bids. If a Board member has such a financial interest, the district is barred from entering into the contract. (Government Code 1090; Klistoff v. Superior Court, (2007) 157 Cal.App. 4th 469)

A Board member shall *not* be considered to be financially interested in a contract if his/her interest is a "noninterest" as defined in Government Code 1091.5. One such noninterest is when a Board member's spouse/registered domestic partner has been a district employee for at least one year prior to the Board member's election or appointment. (Government Code 1091.5)

A Board member shall *not* be considered to be financially interested in a contract if he/she has only a "remote interest" in the contract as specified in Government Code 1091 and if the remote interest is disclosed during a Board meeting and noted in the official Board minutes. The affected Board member shall not vote or debate on the matter or attempt to influence any other Board member to enter into the contract. (Government Code 1091)

Even if there is not a prohibited conflict of interest, a Board member shall abstain from voting on personnel matters that uniquely affect his/her relatives. However, a Board member may vote on collective bargaining agreements and personnel matters that affect a class of employees to which his/her relative belongs. Relative means an adult who is related to the Board member by blood or affinity within the third degree, as determined by the common law, or an individual in an adoptive relationship within the third degree. (Education Code 35107)

A relationship within the third degree includes an individual's parents, grandparents, great-grandparents, children, grandchildren, great-grandchildren, brothers, sisters, aunts, uncles, nieces, nephews, and the similar family of the individual's spouse/registered domestic partner unless the individual is widowed or divorced.

Common Law Doctrine Against Conflict of Interest

A Board member shall abstain from any official action in which his/her private or personal interest may conflict with his/her official duties.

Rule of Necessity or Legally Required Participation

On a case-by-case basis and upon advice of legal counsel, a Board member with a financial interest in a contract may participate in the making of the contract if the rule of necessity or legally required participation applies pursuant to Government Code 87101 and 2 CCR 18708.

Incompatible Offices and Activities

Board members shall not engage in any employment or activity or hold any office which is inconsistent with, incompatible with, in conflict with, or inimical to the Board member's duties as an officer of the district. (Government Code 1099, 1126)

Gifts

Board members and designated employees may accept gifts only under the conditions and limitations specified in Government Code 89503 and 2 CCR 18730.

The limitation on gifts does not apply to wedding gifts and gifts exchanged between individuals on birthdays, holidays, and other similar occasions, provided that the gifts exchanged are not substantially disproportionate in value. (Government Code 89503)

Gifts of travel and related lodging and subsistence shall be subject to the current gift limitation except as described in Government Code 89506.

A gift of travel does not include travel provided by the district for Board members and designated employees. (Government Code 89506)

Honoraria

Board members and designated employees shall not accept any honorarium, which is defined as any payment made in consideration for any speech given, article published, or attendance at any public or private gathering, in accordance with law. (Government Code 89501, 89502)

The term *honorarium* does not include: (Government Code 89501)

1. Earned income for personal services customarily provided in connection with a bona fide business, trade, or profession unless the sole or predominant activity of the business, trade, or profession is making speeches
2. Any honorarium which is not used and, within 30 days after receipt, is either returned to the donor or delivered to the district for donation into the general fund without being claimed as a deduction from income for tax purposes

Incompatible Activities

~~Board of Education members shall not engage in any employment or activity which is inconsistent with, incompatible with, in conflict with or inimical to the Board member's duties as an officer of the district. (Government Code 1126)~~

Conflict of Interest Code

~~The district's conflict of interest code shall be comprised of the terms of 2CCR 18730 and any amendments to it adopted by the Fair Political Practices Commission, together with a district attachment specifying designated positions and the specific types of disclosure statements required for each position.~~

~~Upon direction by the code reviewing body, the Board shall review the district's conflict of interest code in even-numbered years. If no change in the code is required, the district shall submit by October 1 a written statement to that effect to the code reviewing body. If a change in the code is necessitated by changed circumstances, the district shall submit an amended code to the code reviewing body. (Government Code 87306.5)~~

~~When a change in the district's conflict of interest code is necessitated by changed circumstances, such as the creation of new designated positions, amendments or revisions, the changed code shall be submitted to the code reviewing body within 90 days. (Government Code 87306)~~

~~When reviewing and preparing conflict of interest codes, the district shall provide officers, employees, consultants and members of the community adequate notice and a fair opportunity to present their views. (Government Code 87311)~~

~~If a Board member or designated employee determines that he/she has a financial interest in a decision, as described in Government Code 87103, this determination shall be disclosed. The member shall be disqualified from voting unless his/her participation is legally required. (2 CCR 18700)~~

Financial Interest

~~A Board member who manages public investments pursuant to Government Code 87200 and who has a financial interest in a decision shall, upon identifying a conflict or potential conflict of interest and immediately prior to the consideration of the matter, do all of the following:~~

- ~~1. Publicly identify the financial interest that gives rise to the conflict or potential conflict of interest in detail sufficient to be understood by the public, except that disclosure of the exact street address of a residence is not required. (Government Code 87105)~~
- ~~2. Recuse himself/herself from discussing and voting on the matter, or otherwise acting in violation of Government Code 87100. This Board member shall not be counted toward achieving a quorum while the item is discussed. (Government Code 87105; 2 CCR 18702.5)~~

INFORMATION ITEM NO. I.03

This item is to inform the Board of Education of revisions made to AR 1250 – Visitors/Outsiders.

COMMENT: CSBA is recommending this regulation update to clarify a principal's or designee's registration authority and the process for appeal.

The revised regulation is attached. (Revisions to the BP can be found under Discussion Items.)

VISITORS/OUTSIDERS

The Superintendent or designee shall post at every entrance to each school and school grounds a notice setting forth visitor registration requirements, hours during which registration is required, the registration location, the route to take to that location, and the penalties for violation of registration requirements. (Penal Code [627.6](#))

Unless otherwise authorized by the principal or designee, a staff member shall accompany visitors/outsideers while they are on school grounds.

Registration Procedure

Consistent with BP 1250, the following procedures will be followed in dealing with outside visitors to school campuses:

1. Immediately upon entering any school building or the school grounds, any person who is not a student of the school or an officer or employee of the district shall, when school is in session, sign in when entering and sign out when leaving at the principal's office. A visitor's badge will be issued. Any person requested by the principal or designee to leave school grounds shall promptly comply. (Penal Code 627.7)
2. Persons who fail to report their presence and the reason for visiting the school within a reasonable time or who fails to leave school grounds upon request of the principal or designee, or who returns after leaving school grounds pursuant to such request has committed an unlawful act and may be prosecuted according to law.
3. ~~Visitors who comply with the request of the principal or designee to depart may appeal to the Superintendent or designee. The appeal must be made within five days after the person has departed from the school campus. The appeal must include why the request to depart was improper and an address to which a hearing notice may be sent. Upon receipt of the appeal request, the Superintendent or designee shall mail a notice of the hearing to the requester. The appeal hearing shall be held within seven days after receipt of the request.~~

~~(Note: The requirements and timelines indicated above are specified in Penal Code 627.5. The appeal request may be submitted to the Superintendent or principal.)~~

4. ~~The decision of the Superintendent or designee may be appealed to the Board of Education. The Board shall consider and decide the appeal at its next scheduled regular public meeting. The decision of the Board shall be final.~~

Denial of Registration Principal's Registration Authority

The principal or designee may refuse to register any outsider if he/she reasonably concludes that the outsider's presence or acts would disrupt the school, students, or employees; would result in damage to property; or would result in the distribution or use of a controlled substance. The principal or designee or school security officer may revoke an outsider's registration if he/she has a reasonable basis for concluding that the outsider's presence on school grounds would interfere or is interfering with the peaceful conduct of school activities or would disrupt or is disrupting the school, students or staff. (Penal Code [627.4](#))

When an outsider fails to register, or when the principal or designee denies or revokes an outsider's registration privileges, the principal or designee may request that the individual promptly leave school grounds. When an outsider is directed to leave, the principal or designee shall inform him/her that if he/she reenters the school within seven days he/she may be guilty of a misdemeanor subject to a fine and/or imprisonment. (Penal Code 627.7)

Appeal Procedure

Any person who is denied registration or whose registration is revoked may appeal to the Superintendent or principal by submitting, within five days after the person's departure from school, a written request for a hearing. This request must state why he/she believes the denial or revocation was improper and must provide an address to which the hearing notice may be sent. Upon receipt of the request for a hearing, the Superintendent or principal shall promptly mail a notice of the hearing to the person requesting it. A hearing before the Superintendent or principal shall be held within seven days after receipt of the request. (Penal Code 627.5)

The decision of the Superintendent or designee may be appealed to the Board of Education. The Board shall consider and decide the appeal at its next scheduled regular public meeting. The decision of the Board shall be final.

INFORMATION ITEM NO. I.04

This item is to inform the Board of Education of revisions made to AR 1321 – Williams Uniform Complaint Procedures.

COMMENT: CSBA is recommending this mandated regulation update to revise for consistency with the California Department of Education's (CDE) Categorical Program Monitoring process, including (1) authorizing complaints when a student is provided photocopied sheets from a textbook, (2) amending the definition of "emergency or urgent threat" to include other conditions deemed appropriate, (3) amending the definition of "open restroom" to clarify that it does not include the temporary closing for repairs or safety reasons, and (4) adding a statement that a complaint form must be available at each school.

The revised regulation is attached.

WILLIAMS UNIFORM COMPLAINT PROCEDURES**Types of Complaints**

The district shall use the following procedures to investigate and resolve complaints when the complainant alleges that any of the following has occurred: (Education Code [35186](#); 5 CCR [4681](#), [4682](#), [4683](#))

1. Textbooks and instructional materials
 - a. A pupil, including an English learner, does not have standards-aligned textbooks or instructional materials or state- or district-adopted textbooks or other required instructional materials to use in class.
 - b. A pupil does not have access to textbooks or instructional materials to use at home or after school. This does not require two sets of textbooks or instructional materials for each pupil.
 - c. Textbooks or instructional materials are in poor or unusable condition, have missing pages, or are unreadable due to damage.
 - d. A pupil was provided photocopied sheets from only a portion of a textbook or instructional materials to address a shortage of textbooks or instructional materials.
2. Teacher vacancy or misassignment
 - a. A semester begins and a teacher vacancy exists.
 - b. A teacher who lacks credentials or training to teach English learners is assigned to teach a class with more than 20 percent English learner pupils in the class.
 - c. A teacher is assigned to teach a class for which the teacher lacks subject matter competency.

Teacher vacancy means a position to which a single designated certificated employee has not been assigned at the beginning of the year for an entire year or, if the position is for a one-semester course, a position to which a single designated certificated employee has not been assigned at the beginning of the semester for an entire semester. (Education Code [35186](#); 5 CCR [4600](#))

Beginning of the year or semester means the first day classes necessary to serve all the pupils enrolled are established with a single designated certificated employee assigned for the duration of the class, but not later than 20 working days after the first day pupils attend classes for that semester. (5 CCR [4600](#))

Misassignment means the placement of a certificated employee in a teaching or services position for which the employee does not hold a legally recognized certificate or credential or the placement of a certificated employee in a teaching or services position that the employee is not otherwise authorized by statute to hold. (Education Code [35186](#); 5 CCR [4600](#))

3. Facilities

- a. A condition poses an emergency or urgent threat to the health or safety of pupils or staff.

Emergency or urgent threat means structures or systems that are in a condition that poses a threat to the health and safety of pupils or staff while at school, including, but not limited to, gas leaks; nonfunctioning heating, ventilation, fire sprinklers, or air-conditioning systems; electrical power failure; major sewer line stoppage; major pest or vermin infestation; broken windows or exterior doors or gates that will not lock and that pose a security risk; abatement of hazardous materials previously undiscovered that pose an immediate threat to pupils or staff; or structural damage creating a hazardous or uninhabitable condition; or any other condition deemed appropriate. (Education Code [17592.72](#))

- b. A school restroom has not been cleaned, maintained, or kept open in accordance with Education Code [35292.5](#).

Clean or maintained school restroom means a school restroom has been cleaned or maintained regularly, is fully operational, or has been stocked at all times with toilet paper, soap, and paper towels or functional hand dryers. (Education Code [35292.5](#))

Open restroom means, except as necessary for pupil safety or to make repairs, the school has kept all restrooms open during school hours when pupils are not in classes and has kept a sufficient number of restrooms open during school hours when pupils are in classes. This does not apply when the temporary closing of the restroom is necessary for pupil safety or to make repairs. (Education Code [35292.5](#))

4. High school exit examination intensive instruction and services

A pupil, including an English learner, who has not passed the exit exam by the end of grade 12 was not provided the opportunity to receive intensive instruction and services pursuant to Education Code [37254](#)(d)(4) and (5) after completion of grade 12 for two consecutive academic years or until the pupil has passed both parts of the exam, whichever comes first. (Education Code [35186](#))

Filing of Complaint

A complaint alleging any condition(s) specified in items #1-3 above shall be filed with the principal or designee at the school in which the complaint arises. The principal or designee shall forward a complaint about problems beyond his/her authority to the Superintendent or designee in a timely manner, but not to exceed 10 working days. (Education Code [35186](#); 5 CCR [4680](#))

A complaint alleging any deficiency specified in item #4 above shall be filed with a district official designated by the Superintendent. Such complaints may be filed at the district office or at a school site and shall be immediately forwarded to the Superintendent or designee. (Education Code [35186](#))

Investigation and Response

The principal or designee shall make all reasonable efforts to investigate any problem within his/her authority. He/she shall remedy a valid complaint within a reasonable time period not to exceed 30 working days from the date the complaint was received. (Education Code [35186](#); 5 CCR [4685](#))

Complaints may be filed anonymously. If the complainant has indicated on the complaint form that he/she would like a response to the complaint, the principal or designee shall report the resolution of the complaint to him/her within 45 working days of the initial filing of the complaint. If a response is requested, the response shall be made to the mailing address of the complainant as indicated on the complaint form. At the same time, the principal or designee shall report the same information to the Superintendent or designee. (Education Code [35186](#); 5 CCR [4680](#), [4685](#))

When Education Code [48985](#) is applicable and the complainant has requested a response, the response shall be written in English and in the primary language in which the complaint was filed. (Education Code [35186](#))

If a complainant is not satisfied with the resolution of a complaint, he/she has the right to describe the complaint to the Board of Education at a regularly scheduled meeting. (Education Code [35186](#); 5 CCR [4686](#))

For any complaint concerning a facilities condition that poses an emergency or urgent threat to the health or safety of pupils or staff as described in item #3a above, a complainant who is not satisfied with the resolution proffered by the principal or Superintendent or designee may file an appeal to the Superintendent of Public Instruction within 15 days of receiving the district's response. The complainant shall comply with the appeal requirements specified in 5 CCR [4632](#). (Education Code [35186](#); 5 CCR [4687](#))

All complaints and written responses shall be public records. (Education Code [35186](#); 5 CCR [4686](#))

Reports

The Superintendent or designee shall report summarized data on the nature and resolution of all complaints to the Board and the County Superintendent of Schools on a quarterly basis. The report shall include the number of complaints by general subject area with the number of resolved and unresolved complaints. These summaries shall be publicly reported on a quarterly basis at a regularly scheduled Board meeting. (Education Code [35186](#); 5 CCR [4686](#))

Forms and Notices

The Superintendent or designee shall ensure that the district's complaint form contains a space to indicate whether the complainant desires a response to his/her complaint and specifies the location for filing a complaint. A complainant may add as much text to explain the complaint as he/she wishes. However, complainants need not use the district's Williams complaint form in order to file a complaint. (Education Code [35186](#))

The Superintendent or designee shall ensure that a notice is posted in each classroom in each school containing the components specified in Education Code [35186](#). (Education Code [35186](#))

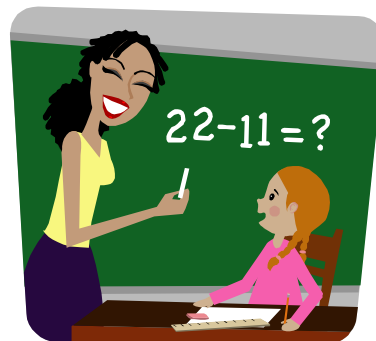
STATE OF EMERGENCY

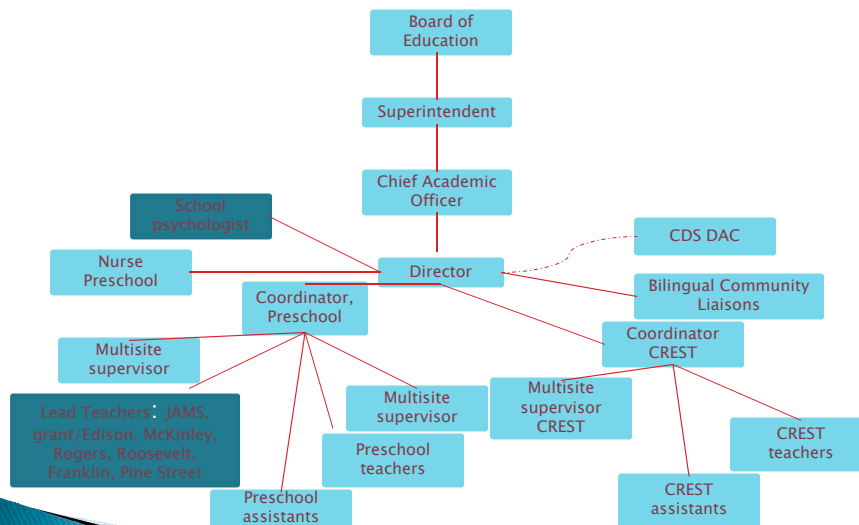
Planning Assumptions 2011-12
