A regular meeting of the Santa Monica-Malibu Unified School District Board of Education was held on Thursday, January 17, 2013, in the District Administrative Offices: 1651 16<sup>th</sup> Street, Santa Monica, CA. 5:55 pm • Reverend Martin Luther King, Jr. Day Celebration (15)

Ms. Harris, Director of Curriculum and Instruction, introduced Ms. Lori Orum, Principal of Edison Language Academy. Ms. Orum informed the board that each year, Edison celebrates the life and teachings of Dr. Martin Luther King, Jr., in different ways. This year, they had an actress come and perform the life of Harriet Tubman during an assembly. Ms. Orum shared Dr. King portraits from kindergarteners in Jamila Banks's class. She then introduced five Edison fourth graders from Ms. Sandra Brummer's class – Anya Bardach, Richard Andres Wladich, Emery Komlos, Katerina Ceguerra, and Joseph de la Torre – who read their summaries of the assembly in English and in Spanish. They explained how Dr. King's work was influenced by the consequences of slavery, how he taught demonstrated kindness and justice. Every year, to celebrate Dr. King's teachings, Edison students and staff create a long paper chain from pieces of paper on which they have recorded their own acts of kindness. The chain, when complete, will decorate the

school cafeteria. The students provided a piece of paper to each board member, so that they, too, could contribute to the Acts of Kindness chain.

### A. Student Board Member Reports (15)

### Yuri Kawashima - Santa Monica High School

Student Board Member Kawashima reported that the second semester has started, and everyone is excited for the rest of the school year. As a senior, she is personally looking forward to the end-of-year events and realizes that she needs to truly enjoy these last few months of high school. ASB has been working on ratifying the associate student body constitution, including a section that addresses GPA eligibility requirements for students running to serve on the council as well as those who already hold an office. Last week was the opening of the Homegrown Art show, and the school raised over \$400 for the art program. The band program had its Winter Concert in Barnum Hall on Tuesday. Today, the Senior Steering Club hosted a California Pizza Kitchen Fundraiser (on Wilshire Blvd.) and the Rotary Club Art Contest in Barnum Hall. Tomorrow, there is a jazz band concert in Barnum Hall at 7:00pm. The winter sports have started league this week, and the basketball team beat Beverly Hills with a very close 63-62 points. On January 22, Sophomore Steering is having a Souplantation fundraiser. January 25 is the annual Café Samo, where students get to showcase their talent while enjoying coffee. ### C. S.E.I.U. Update – Ms. Keryl Cartee-McNeely (5)

Ms. Cartee-McNeely commented on the study session from earlier in the evening. Her own children are biracial and grandchildren are multi-racial, so she was heartened by the conversation. SEIU is participating in a Martin Luther King, Jr., parade this weekend. An SEIU member from LAUSD will be attending the presidential inauguration. SEIU will continue its political campaigns for the City of Los Angeles races. The union's negotiation team has completed its Interest-Based Bargaining training and will be sunshining with the district next month. SEIU also continues to participate in the District Leadership Team and Superintendent's Advisory Council. The union will be establishing mini management teams to meet with departments to improve communication and transparency. Ms. Cartee-McNeely thanked the district for inviting her to attend the Governor's Budget Workshop yesterday. She found it to be informative and valuable.

### D. PTA Council – Ms. Patti Braun (5)

Ms. Braun thanked Mr. Allen for serving as liaison to the PTA council for the last year. She congratulated Ms. Lieberman and Ms. Leon-Vazquez for becoming Board President and Vice President, respectively. Her son informed her that the lockdown at Lincoln MS today ran smoothly and everyone was safe. Ms. Braun shared her Council President priorities for 2013. First, she plans to implement a School Smarts program at five schools during which parents can learn about the school system, the Board of Education, parent conferences, how to get their students into college, and how to advocate for their students. Second, she plans to have PTA continue a smooth transition into centralized fundraising.

### 10:34 pm XI. SUPERINTENDENT'S REPORT (5)

Superintendent Lyon reported that the district has been taking a serious look at safety since tragedy in Newtown, CT. The district's safety committee will be visiting each site's safety committee to discuss areas for improvement, both immediate and long-term, such as ensuring regular drills, examining campus entrances, having each employee wear his/her badge, having visitors sign in, and improving upon emergency response systems. The Education Foundation's Dollar a Day campaign for centralized fundraising is underway. The goal is for 100% participation, but the district understands that not every family can afford that level of contribution, which is why it is important that families who can afford to give more do, but each family participate to the best of their ability. The revised master agreement for centralized fundraising and policy regarding the naming of facilities and programs will come forward at the next board meeting. The Superintendent's Advisory Committee will meet on Monday, January. Lincoln Middle School student Johnny Butchko is

advocating for the local AMC theaters to install functioning closed captioning in their theaters. Johnny, who is deaf, is featured in video on HearingLikeMe.com (click on Learning and then The Perfect Combination) that illustrates the partnership among parents, school, and student to create success for students with disabilities. The video features Johnny, his parents, and Lincoln MS Principal Suzanne Webb. The Business and Fiscal Department is hosting a How to Read Your Paycheck and W2 Workshop for employees. Ms. Lyon reported that she attended a Board of Supervisors meeting to join others in protesting a funding measure that would dramatically affect school districts. The Board of Supervisors delayed action and extended the protest period. The superintendent submitted a letter of protest with SMMUSD's affective parcel numbers. She will provide the board with a sample resolution of protest to consider adopting.

Mr. Allen would like a study session on school safety. Mr. Mechur suggested that staff provide the board with a report, rather than full study session. The superintendent board president, and vice president will discuss this.

### STUDY SESSION ITEM NO. S.01

At the December 13, 2012, Dr. Terry Deloria, Assistant Superintendent of Educational Services, outlined the planned district approach to closing the achievement gap. During tonight's study session, district staff will present the multi-pronged plan to the Board of Education. Representatives from The Village Nation will also present a summary of their program to the Board of Education and explain the work they have done so far with staff and students at Samohi and how their program fits into the overall plan the district has to address both the needs of African American students and the achievement gap as it pertains to students in our district.

 Joanne Berlin, Dawn Smith, Debra Shepherd, Robert Gordin, Reuben Branfman, Lisa Balfus, Yvonne Dawson, Tory Dawson, Gary Avrech, Janet McKeithen, Craig Foster, Joette Marks, Maurice Maxwell, Robbie Jones, Cindy Keel, Lorraine Crump, and Dominick Love addressed the board regarding this item.

Dr. Deloria and Ms. Harris's presentation can be found under Attachments at the end of these minutes. As part of the presentation, Fluke Fuker, Co-founder of The Village Nation (TVN) program, summarized the program and its work at Samohi so far. Mr. Fluker answered board members' questions about the program.

Mr. de la Torre supported implementing TVN, with customizations to meet the specific needs of Samohi. He wondered if the district was staffed appropriately to carry out the plan. Dr. Escarce said he valued the mentorship and student reflection aspects of the plan and TVN. Mr. Mechur emphasized the need for a cohesive approach, involving the school district and community. He said that TVN can be a part of that overarching plan for the success of all students, but should not be the main part.

#### **RECOMMENDATION NO. A.08**

It is recommended that the Board of Education ratify the District Purchasing Director's execution of the Consent and Agreement to consent to the reassignment of the Solar Service Agreement, (SSA), Solar Easement and License Agreement and First Amendment (project agreements) dated December 21, 2010, from RF Santa Monica Development Corporation (RFSM) to DFX Acquisition LLC (DFX).

Comment: RFSM defaulted in their agreement with DFX, who held secure loans of RFSM assets. RFSM filed bankruptcy on October 11, 2012. The U.S. Bankruptcy Court ordered that DFX be granted the project agreements with Santa Monica-Malibu Unified School District contract for the solar installations at nine (9) facilities as collateral on their secured loan.

Staff has been working with legal counsel and bankruptcy attorneys to assure that all of the District's interests have been met, while keeping the integrity of the solar project whole and see to the solar project through to its completion.

All original contract documents are in place, with no changes to the documents except for the following: The District will be allowed to keep all emission credits, allowances and emission reduction credits.

Further, counsel secured corrective payments in the amount of \$136,527.12 for reimbursement of staff, inspection services and construction management expenses, \$25,000 in attorney's fees an DFX's agreement to reimburse the District for future inspection and construction management services through the duration of the solar project.

The Purchasing Director executed the Consent and Agreement on January 3, 2013, so that construction of the solar project may resume allowing for completion before certain tax incentives central to the project agreements expire.

Construction resumed on January 4, 2013. The estimated completion date is May 1, 2013.

## Resolution No. 12-11 Commemorating Dr. Martin Luther King, Jr. Day

Whereas, Dr. Martin Luther King, Jr. was born in 1929 in Atlanta Georgia;

**Whereas**, the young Martin Luther King attended segregated public schools and graduated from high school at age 15;

**Whereas**, Dr. King received his B.A. degree from Morehouse College in Georgia, the alma mater of both his father and grandfather and earned his B.D. from Crozer Theological Seminary. Later, in 1955, he received a Ph.D. from Boston University;

**Whereas**, Dr. King was committed to equal rights for African-Americans in this country from an early age and was an active member of the NAACP;

**Whereas**, Dr. King led the boycott of Montgomery's segregated buses for over a year after Rosa Parks refused to give up her seat in a bus in 1955, and eventually, the Supreme Court outlawed discrimination in public transportation and Dr. King emerged a prominent leader of the civil rights movement;

**Whereas**, Dr. King began organizing protest demonstrations and marches in such cities as Birmingham, Alabama, St. Augustine, Florida and Selma, Alabama. The marches were for the right to vote, desegregation, labor rights and other basic civil rights.

**Whereas**, between 1957 and 1968, Dr. King canvassed the country and appeared more than 2500 times to speak in protest against injustices toward his race;

**Whereas**, Dr. King wrote five books and numerous articles drawing on his experience as a preacher to galvanize and inspire an audience. Dr. King was arrested and jailed on several occasions;

**Whereas**, on August 28, 1963, Dr. King led the great march in Washington, DC, that culminated with his famous "I Have a Dream" speech at the Lincoln Memorial. More than a quarter million people of all ethnicities attended the event.

**Whereas**, at the height of Dr. King's influence, the Civil Rights Act of 1964 and the Voting Rights Act of 1965 were passed.

Whereas, Dr. King was awarded the Nobel Peace Prize in 1964, at the age of 35.

**Whereas**, Dr. King continued his work to attack discrimination in other parts of the North and broadened his criticism against the Vietnam War;

**Whereas**, Dr. King advocated for government compensatory program seeking restitution of wages lost to slavery which in turn, demanded aid for the poorest communities and sought an economic bill of rights that provided for massive government job programs to reconstruct society;

**Whereas**, Dr. King continued to participate in the movement by supporting black city workers striking for higher wages and better treatment in Memphis, Tennessee where he was assassinated:

Whereas, in 1986, Congress established the Martin Luther King Day as a United States holiday and in 1994, King Day of Service was built on the teachings of nonviolence and social justice to promote community service. The aim is to make the holiday a day ON, where people of all ages and backgrounds come together to improve lives, bridge social barriers, and move our nation closer to the "Beloved Community" that Dr. King envisioned.

**Therefore, let it be resolved**, that the Santa Monica-Malibu Unified School District celebrates the life and legacy of a man who brought hope and healing to America. We commemorate the timeless values he taught us through his example – the values of courage, truth, justice, compassion, dignity, humility and service that so radiantly defined Dr. King's character and empowered his leadership. On this holiday, we commemorate the universal, unconditional love, forgiveness and nonviolence that empowered his revolutionary spirit, and speaks to the best of who we are as human beings.

**Be it further resolved**, that our schools, offices, and broader community become places that embody the spirit of this great American by promoting and embracing reconciliation, respect, brotherhood, and our common humanity, not just today, but every day of the year.

## **INFORMATION ITEM NO. I.03**

This is to inform the Board of Education that the Theatre Operations and Facility Permits Department has changed its name to the Facility Use Department.

COMMENTS: The expansion of the Theatre Operations and Facility Permit Department has made the department name inaccurate, representing only a portion of the scope of the office. The new title, Facility Use Department, incorporates all aspects of the department.

The department is a function of the Business Services Office. It has expanded to support all outside facility use of District property. This includes four aspects that have been added incrementally of the last six years:

- Theater Operations manages Filming, Large Special Events and Theater Use. This part of the office supports student productions, District events and News/PSA/Document filming of students. The staff includes the Technical Theater and Media Services Coordinators.
- Facility Permits issues and manages permits for community and commercial groups to use the all other facilities. This includes cafeterias, libraries, classrooms, gyms, pools, fields, etc. This office supports the facility use of Affiliated Groups, such as PTAs, Booster Clubs and the Education Foundation. This is the Civic Center Use part of the Department. The staff includes the Facility Permit Supervisor.
- Joint Use coordinates and supports the joint use of facilities by the Cities
  of Santa Monica and Malibu and of Santa Monica College. We
  administer the Santa Monica Playground Partnership, Upper CREST
  Program, Middle School Programs and Samohi Athletic Joint Use, along
  with the Malibu Athletic Facility Use and Camps and the Equestrian Park.
- Lease supports the Business Office in the management of leased properties.

The mission of the department is to make facilities available for use by outside groups to generate revenue to maintain these facilities and encourage positive community experience of our facilities.




## **Funding for NBCTs in SMMUSD**

- For the 2012-2013 school the candidate cost is:
  - Our district reimburses for the cost of the Certification process. The cost is \$2500
    - We also ask candidates to apply for a California state subsidy. If they receive the subsidy, we reimburse the remaining \$1250
  - Our district provides 2 sub days during the certification process
- For the 2012-2013 school the NBCT cost is:
  - 26 NBCT receiving \$10,000 stipends for a total of \$260,000
  - 43 NBCT receiving \$5,000 stipends for a total of \$215,0000
  - The total amount for the 2011-2012 school year equals \$475,000



## Conceptual Framework: All Schools



- · All schools and district office, all staff, all students
- Most activities/actions are not program-based.

#### School and District Culture

- Cultural Proficiency Training: This on-going, comprehensive training leads to the reshaping of every school's culture in becoming culturally competent and responsive.
- Survey on Cultural Proficiency: Staff, students and the community will participate in an annual cultural proficiency surveys to generate baseline and annual formative data to inform improvement plans.
- Family-Friendly Schools: Making schools more welcoming to families, especially those of marginalized or under-represented students can have a direct impact on student performance.

#### School and District Culture

- School, Family and Community Partnerships: Student achievement improves when schools, families, and communities work together. Engaging parents of underperforming students requires school and district leaders to understand the diversity in family types along with the many ways families can become involved in their children's education.
- District Equity and Access Ad Hoc Committee: District staff facilitate meetings with leaders from various advisory groups to create a two-way system of communication to related to this action outline for equity and access to student success.

### Teaching and Learning

- Five Year Plan to Monitor and Narrow Gaps: Working with baseline (2011-12) data, school leadership teams will develop action outlines that include focused, measureable goals in academics, college readiness, attendance, discipline and other metrics and targeted activities that dramatically narrow achievement gaps over a period of five years.
- Pyramid of Interventions: School leadership teams will develop their initial version of a pyramid of interventions that help prevent students from falling between the cracks in four areas: Academics, Attendance, Discipline, and Wellness.

## Teaching and Learning

- Building Background Knowledge through Schoolwide Literacy: The most straightforward ways to enhance students' academic background knowledge is to provide academically enriching experiences (Science Center, Aquarium, beach trips, etc.) and community mentoring programs. A more viable option is to generate virtual experiences through school-wide literacy strategies (academic vocabulary, explicit reading strategies, etc.)
- Advanced Placement (AP) STEM Access Program: Through a grant funded by Google, this initiative seeks to increase the number of traditionally underrepresented high school students that participate in AP courses in STEM (science, technology, engineering and math) disciplines.

### Teaching and Learning

- Instructional Strategies for Targeted Subgroups: Teacher leaders will become experts in research-based instructional strategies and, in turn, will train and support all teachers and paraprofessionals at their school sites.
- 1-1 Computing: Currently, achievement gaps are aggravated by the inequitable student access to technology By the spring of 2015, every student will has access to his/her own device, software and the Internet during the school day. Older students will have 24-7 access. The district will provide the resources to low-income families.

### Teaching and Learning

- Ethnic Studies Course: Students will learn the stories, histories, struggles and triumphs of people of color. The course description will come to the BOE for approval in March 2013.
- Preschool and Out-Of-School Programs: Gaps in achievement begin well before kindergarten. Principals, educational services and Child Development Services staff will collaborate to align teaching and learning outcomes and practices.

### Mentoring and Advocacy

- Safe School Ambassadors: This program is an "inside-out" approach to improving school climate, one that relies on social norms change and the power of students to help stop bullying and violence.
- Community Mentoring Program: The Community Mentoring Program links role models drawn from members of the community, with those students most at risk. This program will link mentors who are volunteers from business, industry, or community organizations, with young people between 12 18 years.

### Mentoring and Advocacy

- African American College Empowerment: School and district staff work with students to develop college-going identities through a variety of activities. One major event is the summit that features workshops, a college fair, and guest speakers who discuss the importance of strengthening community, developing leadership skills and preparing for college.
- The Village Nation: The Village Nation seeks to create a safe environment for African American students. Staff trained as Elders volunteer to create learning activities and social venues that support academic and social success.

### Policy and Practice

- Focus: When the number of initiatives increases, while the amount of time, resources and emotional energy remain constant, then each new initiative—urgent or not—will receive fewer minutes, dollars and ounces of emotional energy than its predecessors. If we all focus on a few, crucial goals, we can make swift, dramatic progress.
- School Policy and Practice: School leadership teams will review (and remedy as needed) systems or structures that create barriers for underperforming students or their families.

## Policy and Practice

- Advisory Committees and Community Partnerships: The collective impact of commissioning parent and community groups to align their vision, goals and actions with the District's Equity and Access for Student Success Plan is both desirable and necessary for solving the complex problem of closing achievement gaps. This includes partnerships with the City of Santa Monica and Santa Monica College.
- Assessment and Monitoring Plan: Staff will create a set of academic and behavioral metrics that can be used to formatively measure improvement and report progress quarterly to the BOE. Additional evaluation practices will be aligned to include performance indicators for closing achievement gaps.

## Questions





- For the first time in five years, education funding goes up on a per-student basis – recovery starts now
- The Governor's proposed Weighted Student Formula of 2012 is reprised as the Local Control Funding Formula (LCFF) and redistributes funding gains
- Passage of Proposition 30\* provides opportunities and options

<sup>\*</sup> Schools and Local Public Safety Protection Act of 2012 (sponsored by Governor Jerry Brown)





- The revenue limit deficit continues to be more than 20%, but for the first time since 2007-08 does not get larger
- The Governor continues to deal with the "wall of debt," but does not dedicate all of the growth in Proposition 98 to this single purpose
- The Legislative Analyst's Office (LAO) forecasts that the Proposition 98 guarantee will grow at a 3.4% to 5.3% rate over the next several years

## The Distribution Method is Different

- Along with slightly higher funding, the Governor proposes a different method of distribution – the LCFF
  - Revenue limits and categorical programs are replaced by base grants and supplemental grants over a phase-in period
  - The stated goal is to focus more resources on California's most needy students



## Passage of Proposition 30 Provides Opportunities and Options

- The recent passage of Proposition 30 can be largely attributed to the Governor's leadership and the education community uniting for passage
- It provides a narrow window during which further Budget cuts are avoided and some hope of future gains is offered
- But this window is a temporary solution; how we use this opportunity matters
  - Thus far, state and federal sources of funding have been used to buffer those most negatively affected by the economic collapse
  - Now is the time to channel funding into those areas that truly make a difference in the long term
- Public education is a game changer
  - Now is the time for a shift in state policy toward preparation of our children for what is sure to be a challenging future

# Economics Still Rule

- State policy is important, but the revenues that give the state options are driven by economics
- The economy is no longer shrinking, but it is not growing at a recovery rate
  - Employment numbers are still fragile
  - Both the state and federal governments face ongoing economic challenges
- The state has choices
  - Wait and hope for recovery?
  - Take actions that drive the recovery?
  - The Governor is trying to drive change
- Many of the problems we see are international, structural, and long term
- This economy is fragile and we need to treat it gently



## More Funding Leads to Higher Expectations


- The first increase in per-student funding in five years creates higher expectations
  - Funding is still about 10% less than the amount received in 2007-08
  - The deficit factor is still more than 20% because of past cuts and unpaid cost-of-living adjustments (COLAs)
- But pent-up demand for dollars will be strong
- Under the LCFF, not all districts share equally in new dollars
- As a result, it is unlikely that all expectations will be met
  - We are still at the beginning of a turnaround, not the end

## U.S. Economic Outlook

- The U.S. economy continues to be plagued by slow growth, even though the recession was officially declared over in June 2009
- The threat of falling off of the so-called "fiscal cliff" \$600 billion in higher federal taxes and spending cuts – has been avoided in large part
  - The Congress and the President have agreed to avoid raising taxes on all but the top income earners
    - However, the payroll tax cut was allowed to expire
  - Still unresolved, however, are the scheduled cuts to federal programs
- Global trends pose new risks
  - The economies of Japan and European countries are in recession and previously growing economies of China, Brazil, and India are slowing
    - This threatens U.S. exports
- Domestic developments are mixed
  - Hurricane Sandy will depress near-term growth
  - Housing and employment continue to improve







- California's economy is recovering slowly like the U.S. economy
  - Housing is on the upswing, with the median home price up 24% to \$341,000 from the recession low of \$275,000 in 2009
    - However, this is still below the 2007 peak of \$560,000
  - The state has added about 564,000 jobs of the 1.4 million that were lost in the recession
    - The state's unemployment rate dropped to 9.8% in November 2012, compared to 7.7% for the U.S.
    - On average, California added about 22,300 jobs per month over the last 12 months
- California's economy is vulnerable to the global slowdown, especially because of its significant export sector




K-12 Education Expenditures per Average Daily Attendance (ADA) 2010-11

- Increased funding for K-12 education is dependent upon a continued improved economy in the state and the nation
  - State and national economic growth are far from certain
  - California tax revenues are heavily reliant (more than 60%) on personal income taxes – making individual incomes very important to the State Budget
- Rising health care costs will continue to strain the State Budget
- Outstanding budgetary borrowing totaling \$35 billion will continue to limit the amount of available resources
- Other budgetary priorities could threaten resources designated for the Governor's Budget Proposal


## Proposition 98 Minimum Funding Guarantee

- One of three tests determines the level of the Proposition 98 minimum guarantee
- "Test 3" governs the guarantee in 2013-14
  - Test 3 increases the prior-year minimum guarantee based on percentage changes in ADA and in state General Fund revenues
- Minimum guarantee funding grows by \$2.7 billion, to a total of \$56.2 billion for 2013-14 – a 5% increase
  - \$2.4 billion of Proposition 98 funding used in 2012-13 to "buy back" interyear payment deferrals for K-12 schools and community colleges is also available



## Revenue Limits and Local Control Funding Formula

- The Governor proposes a sweeping reform of the state's school finance system with the LCFF
- The Governor's Budget makes no reference to current law and revenue limit funding
  - There is no direct reference to the statutory COLA
    - However, the Budget acknowledges providing a 1.65% COLA for selected categorical programs and sufficient funding to increase support for LEAs by 4.5% under the LCFF
  - There is no reference to the current 22.272% deficit factor
- Nevertheless, until state law is changed, revenue limits are the means by which state apportionment aid is distributed to LEAs statewide







- The LCFF would replace revenue limits and most categorical program funding
  - Funding allocated through the formula would generally be flexible and could be used for any educational purpose
- Elements of the proposed formula
  - A base grant target equal to the undeficited statewide average base revenue limit per ADA – \$6,816 (includes the 1.65% statutory COLA)
  - Differential adjustments for early primary, primary, middle, and high school grade spans; added funding for K-3 Class-Size Reduction (CSR) and 9-12 Career Technical Education (CTE)
  - Additional funding based on the demographics of the schools, including:
    - English Learner population
    - Pupils eligible for free and reduced-price meals
    - Foster youth

# LCFF and Categorical Programs

- Elements of the formula (continued):
  - Special Education, Child Nutrition, QEIA, After School Education and Safety (ASES), and other federally mandated programs are not included in the formula
- Transportation and Targeted Instructional Improvement Grant (TIIG) funding continue as add-ons to the formula for those school districts that currently receive funding through these programs
  - And the funds can be used for any educational purpose
- Timeline: Phased in over seven years completed in 2020-21





- Fully funding the new formula in 2013-14 would cost more than \$15 billion
  - Governor's Proposal sets aside \$1.6 billion
  - A 10% proration factor provides a reasonable estimate, but as more details about the proposal emerges the estimates could change
- Department of Finance staff expect to provide estimates of LEA funding under the Governor's Proposal within the next few weeks
- Most categorical funds are kept in the base, but programs go away

## Where Does the Proposal Stand Now?

- There are <u>currently insufficient details</u> to allow a school district to determine its funding under implementation of the LCFF for 2013-14, or for any year thereafter
- The Legislature must enact this measure as a change to current school finance statutes
- We will provide more information as the details of this proposal are released





- The Governor's Budget assumes that his new LCFF is passed in the Legislature
- There is much to learn about the LCFF proposal, and it is uncertain what would happen to the resources dedicated to the proposal if it does not pass the Legislature
- This leaves schools in a position of needing at least two plans
  - Governor Brown's Proposal: Increased funding 1.65% COLA plus additional revenues associated with the factors in the LCFF
  - A budget for 2013-14 that includes the COLA, less the additional revenues associated with the LCFF
- Districts will need to plan for both eventualities until the details and the fate of the LCFF becomes clear

# Road to Adoption

- As is true every year, the Governor's Budget Proposals mark the beginning – not the end – of the process
  - Both houses of the Legislature will consider the financial and policy implications of the Governor's plan
  - Over the next several months, we will hear reasons for both support and resistance to the Proposal on either a financial or policy basis
  - Governors, including this one, have modified or even dropped proposals they strongly support in order to achieve a greater goal
- The May Revision will surely be different than the economic picture upon which the Budget is based – will it be better or worse?
