A regular meeting of the Santa Monica-Malibu Unified School District Board of Education was held on Thursday, November 7, 2012, in the Malibu City Council Chambers: 23825 Stuart Ranch Road, Malibu, CA. The Board of Education called the meeting to order at 4:45 p.m. in the Zuma Conference Room at the Malibu City Hall. **D. Superintendent – Ms. Sandra Lyon (5)**

*Ms. Lyon updated the board on the recent activities regarding the environmental concerns in Malibu. Mr. Katchen was out of town this week, but will attend the next board meeting and give a thorough presentation. The Malibu Schools Environmental Task Force has held three meetings, and the task force agreed on a testing protocol. Testing has begun at Malibu HS and Cabrillo ES. Dr. Paul Rosenfeld, the environmental consultant hired by a Malibu parent group, met with Mr. Katchen and agreed with the district's testing plan, which includes an education plan for staff and parent communities. Information regarding the testing can be found on the district's website. A list of Frequently Asked Questions can be found online and will be added to as we move forward. Ms. Lyon reported that at this time, the district does not have evidence that the buildings are unsafe.*

*Ms. Lyon shared her recent trip to China as part of the Educational Forum in Shanghai. She traveled with Dr. Janie Gates and former Chief Academic Officer, Dr. Sally Chou. They visited several schools and presented at a forum about the American education system with a focus on how we serve secondary students. While in China, Ms. Lyon met up with Samohi alums.*

STUDY SESSION ITEM NO. S.01

Student Services will present 2012-2013 student suspension data and review changes to the Education Code affecting student suspension and expulsion. Changes to the Education Code seek to give greater discretion to administrators to determine appropriate and effective responses to student misconduct, including using alternative means of correction in lieu of suspension.

In addition to presenting student suspension data and reviewing changes to the Education Code, Student Services will highlight discussions with school administrators regarding the implications of the changes in law and initial efforts to implement alternative means of correction.

*Dr. Kelly's presentation can be found under Attachments at the end of these minutes.*

*Dr. Kelly explained in-school suspensions; the cost in ADA for suspensions; changes in the Education Code regarding suspensions for a first offense; alternative means of correction in lieu of suspension; ongoing training for site administrators; peer mediation; the process of intervention; and the role that counselors, community liaisons, and community partners can play in mediation. He commended our district's teachers for serving as the first point of discipline by implementing effective classroom management.*

*Mr. de la Torre wondered if the district could analyze the academic habits and achievement data, including graduation rate, of students with high suspension rates. He suggested staff examine the recommendations from the Race and Discipline task force that was formed in 2002. Mr. Patel expressed concern over the number of instructional minutes missed during suspensions. Dr. Escarce asked if there was a plan for administrators to discuss their discipline practices with each other to ensure levels of discipline are consistent across the district. Dr. Kelly replied that administrators often process discipline decisions with each other. Dr. Escarce asked what administrators' responses have been to this new trend toward discretion. Dr. Kelly commented that administrators see value in the efforts being made to positively alter student behavior, rather than following strictly mandated consequences. Mr. Allen asked staff to examine what effects removing 48900(k) (willful defiance or disruption) from the suspension list has had on other districts.*

**WHEREAS**, since the earliest days of our Republic, Native Americans have played a vital role in our country's freedom and security, having served in all branches of America's armed forces; and

**WHEREAS**, Native Americans are leaders in every aspect of our society – from the classroom, to the boardroom, to the battlefield; and

**WHEREAS**, Native Americans make up the ranks of both our district's certificated and classified staff as well as our student population; and

**WHEREAS**, Native American and Alaska Native tribal governments are an integral part of social, political, and economic fabric of the United States; and

**WHEREAS**, Tribal America has brought to this great country certain values and ideas that have become ingrained in the American spirit: the knowledge that humans can thrive and prosper without destroying the natural environment; the understanding that people from different backgrounds, cultures, religions, and traditions can come together to build a great country; and the awareness that diversity can be a source of strength, rather than division; and

**WHEREAS**, while we pay tribute to Native American achievements, we must also acknowledge the parts of our shared history that have been marred by violence and tragic mistreatment; and

**WHEREAS**, for centuries, Native Americans faced cruelty, injustice, and broken promises; and

**WHEREAS**, our tribal communities face stark realities, including disproportionately high rates of poverty, unemployment, crime, and disease; and

**WHEREAS**, in 1914, Red Fox James, a Blackfoot Indian, rode horseback from state to state seeking approval for a day to honor Native Americans as the first Americans; and

**WHEREAS**, in 1915, The American Indian Association called for the observance of, and President Coolidge issued a proclamation for, an American Indian Day; and

**WHEREAS**, in 1990, President Bush approved a joint resolution designating November 1990 "National American Indian Heritage Month," and similar proclamations have been issued since 1994; and

**WHEREAS**, in 2009, President Barack Obama, signed a bipartisan resolution that recognized the sad and painful chapters in our shared history, and remains dedicated to writing a new chapter in that history by strengthening our government-to-government relationship with tribal nations while enhancing tribal sovereignty and tribal self-determination; and

**WHEREAS**, the new park on Ocean Ave. in the City of Santa Monica was named Tongva Park to honor and highlight the area's original inhabitants, the Tongva people, who have lived in the Los Angeles area for thousands of years and are deeply connected to the original arroyos, native landscape, springs, and the "breath of the ocean" that are symbolically represented in the park; and

**WHEREAS**, the City of Malibu – which derived its name from Humaliwu, the original Chumash name for the region – hosts an annual Chumash Day Powwow and Intertribal Gathering to honor the city's original settlers, the Chumash Indians; and

**WHEREAS**, school districts across the nation, including our own SMMUSD, can find inspiration and direction in the Great Law of the Iroquois: In every deliberation we should consider the impact of our decisions on the next seven generations;



**RESOLUTION NO. 13-05**

**WHEREAS**, voters in the State of California approved Proposition 13 in 1978; and

**WHEREAS**, Proposition 13 created limits on the property taxes paid by residential and commercial properties; and

**WHEREAS**, residential and commercial property values in California are reassessed upon change of ownership; and

**WHEREAS**, owners of commercial real estate have benefited under current reassessment rules in that if a corporation owning commercial property is sold or merged with another corporation, but the property it owns stays deeded to the corporation, ownership of the property effectively changes without triggering a reassessment of the property; and

**WHEREAS**, corporations often avoid reassessment of their property by limiting the portion of ownership that changes hands to ensure that no single party owns more than 50 percent; and

**WHEREAS**, Proposition 13 is fundamentally unfair and allows corporations to exploit loopholes to avoid paying property taxes and has shifted the tax burden to everyday homeowners and working families; and

**WHEREAS**, loss of revenue from corporate property taxes has led to an increase in regressive taxes and fees that hurt the most vulnerable Californians; and

**WHEREAS**, property taxes are a stable funding source for public schools; and

**WHEREAS**, since the State of California has assumed a greater role in the funding of public schools, per-pupil support has declined from the top 10 in the nation to the bottom 10, resulting in the reduction of programs in the arts, languages, and physical education; the reduction of building maintenance and refurbishment; the loss of nurses, counselors, and librarians; the substantial loss of teachers coupled with a marked increase in class-size; all of which have negatively impacted the quality of public education in California; and

**WHEREAS**, public schools in California face challenges educating a student population with vast differences in language, poverty, parental education level, and other social, educational, and economic factors; and

**WHEREAS**, modifying the method of reassessing commercial property would net needed additional resources for public schools;

**THEREFORE BE IT RESOLVED** that the Santa Monica-Malibu Unified School District Board of Education supports efforts to modify how the value of commercial properties in California are reassessed to allow for more regular commercial property value reassessment; and

**BE IT FURTHER RESOLVED** that the Santa Monica-Malibu Unified School District Board of Education supports this effort while protecting existing protections provided to residential properties; and

**BE IT FURTHER RESOLVED** that tax revenues generated by modernizing how commercial property is reassessed benefit public schools and not accrue to the State of California as General Fund savings; and

**BE IT FURTHER RESOLVED** that the Board of Education will communicate this position to elected officials.

## **CERTIFICATED JOB DESCRIPTION**

### **MENTAL HEALTH COUNSELOR – SPECIAL EDUCATION**

#### **DEFINITION**

Under the general direction of the Director of Special Education or designee, it is the role of the Mental Health Counselor to provide school-based mental health services to students attending Special Education Positive Behavior Support programs. The Mental Health Counselor shall work with teachers and staff to support successful student classroom participation. This position requires specialized subject matter expertise in mental health counseling, special education, threat assessments and behavior modifications. The counselor shall perform other related functions as required.

#### **DISTINGUISHING CHARACTERISTICS**

This position classification requires knowledge, experience, and skill in the areas of mental health counseling, special education, threat assessment, behavior interventions and crisis response. The position requires decision-making and problem-solving with an understanding of local, state, and federal laws and mandates. The Mental Health Counselor meets with students, parents, school administration, teachers, and other staff. Positive Behavior Support programs are essential for students to achieve optimal personal growth, acquire positive social skills and values, and realize full academic potential.

Reasonable accommodation may be made to enable a person with a disability to perform the essential functions of the job.

#### **EXAMPLES OF DUTIES**

- Provides direct counseling services for individuals and groups of students at school sites on a regular basis, and as needed;
- Participates in staff development for school site teachers, DIS providers and Instructional Assistants;
- Participates in crisis response team as needed;
- Facilitates social skills and self-regulatory student groups;
- Assists teachers in developing and implementing behavior interventions;
- Makes home visits, as appropriate;
- Performs other duties as assigned.

#### **QUALIFICATIONS**

##### **Knowledge of:**

1. Current special education and counseling programs including CPI Training and Crisis Response training,
2. Threat assessments, and experience in performing such assessments,
3. Social skills and self-regulated curriculum,
4. Counseling practices and techniques for children.

##### **Skills/Abilities:**

1. Significant, directly-related and progressive experience as a counselor, including working with children,

2. Demonstrated knowledge and experience with programs such as CPI Training and Crisis Response training,
3. Ability to work collaboratively with multi-disciplinary teams,
4. Communicate effectively, in oral and written form, with staff, students, and parents,
5. Lead social skills and self-regulated groups,
6. Utilize technology effectively, using word processing, spreadsheet, database and presentation software.

## **EDUCATION AND EXPERIENCE**

A Pupil Personnel Services School Counseling credential is required.

### **Education:**

Equivalent to the completion of an earned Master's degree or higher in education, special education, psychology, counseling and guidance, social work, or a closely related field.

### **Experience:**

Minimum of three (3) years of successful experience as a school counselor or mental health clinician is required. CPI Training and Crisis Response Training preferred.

## **CERTIFICATIONS, LICENSES AND CONDITIONS**

### **Certification Requirement**

Possession of a valid Pupil Personnel Services (PPS) – School Counseling credential.

### **License Requirement**

Possession of a valid Motor Vehicle Operator's License.

### **Condition of Employment**

Insurability by the District's liability insurance carrier.

## **PHYSICAL REQUIREMENTS AND WORKING CONDITIONS:**

- Candidates must be able to perform essential duties with or without reasonable accommodation.
- This is a sedentary position classification with light work that involves sitting a portion of the time, and includes walking and standing for extended periods.
- Requires the mobility to stand, stoop, balance, reach, kneel and bend. Requires mobility or arms to reach and dexterity of hands and fingers needed to operate a computer keyboard.
- May require the need to push, pull or lift up to 50 pounds.
- The job also requires the accurate perceiving of sound, near and far vision, depth perception, handling and working with educational materials and objects, and providing oral information and direction.
- May be required to provide approved CPI restraints.

This position will have a work year of 193 days, and be compensated based on the SMMUSD Certificated Teaching/Counseling Salary Schedule.

## Alternative Means of Correction

Other means of correction include, but are not limited to:

- Conferences with student's parents, student study teams, and other behavioral groups;
- Referrals to school counselors, psychologists, or other school support service personnel;
- Enrollment in a restorative justice, anger management, or pro-social behavior program;
- Referrals for assessment for purposes of determining special education or Section 504 eligibility;
- Positive behavior support or tiered interventions occurring during the school day;
- After-school programs that address behavioral problems and/or expose students to positive activities;
- Community service.

## Initial Steps in SMMUSD

- Shared 2012 – 2013 suspension data with principals and co-administrators.
- Presented changes to the Education Code to principal and co-administrators at August administrators' retreat.
- Met with Samohi Principal and House Principals to review site discipline matrix, discuss implications of EC changes and strategies for addressing discipline as new administrative team.
- Initiated, and continue to engage principals and co-administrators in dialogue regarding alternative means of correction.
  - Promote and share strategies between sites.
  - Examples: mediation, reflective engagement
- Investigating systemic strategies: mediation training for administrators and school-wide positive behavior support training.

## Legislative Trends

- To give greater discretion to administrators to determine appropriate responses to student misconduct.
- To allow and *mandate* use (and documentation) of alternative means of correction.
  - Eliminate or modify EC 48900 (k).
- To reduce exclusionary discipline, which is deemed ineffective at increasing school safety or improving behavior of disciplined students.
- To modify rigid (zero tolerance) discipline policies and practices to allow for thoughtful responses to student misconduct.
- To address disproportionate effects on African American and Latino students.
- To encourage proactive responses with a focus on prevention.

## Challenges

- What are *effective* alternative means of correction that address and correct student misconduct?
- How do we balance consistency with thoughtful individualized responses to student misconduct?
- How do we manage expectations of teachers, staff, parents, and students that *something must be done*?
- How do we eliminate disproportionate effects on African American and Latino students?
