# The board discussed the following:

- Ed Services presented student achievement data from quarter 2, including the FASTbridge universal literacy screening assessment, rates of non-passing grades, and interim assessments.
- The board discussed updates to BP/AR regarding uniform complaints. These changes will return for action at the next board meeting.

#### The board took action on the following:

- The board adopted a resolution honoring Dr. Martin Luther King, Jr. Day. The resolution highlights his accomplishments in organizing protest demonstrations and marches for the right to vote, desegregation, labor rights and other basic civil rights. At the height of his influence, the Civil Rights Act of 1964 and the Voting Rights Act of 1965 were passed. He was awarded the Nobel Peace Prize in 1964.
- The board adopted a resolution honoring Mr. Fred Korematsu, a Japanese American
  who refused to comply with regulations that required 120,000 Japanese Americans to
  leave their homes and be incarcerated in American concentration camps during WWII.
  Fred T. Korematsu Day of Civil Liberties and the Constitution commemorates the life
  of Fred Korematsu and recognizes the importance of preserving civil liberties, even in
  times of real or perceived crisis.
- The board accepted the 2018-19 Annual Financial Audit Report, which was presented by our accounting firm.

## Special note:

- In honor of Dr. Martin Luther King, Jr's birthday, student council members from Muir ES shared what they had learned about Dr. King's life and teachings. They shared excerpts from his famous speeches and explained why those chose those particular speeches.
- The board adjourned the meeting in memory of Joanne Levitt, a long-time Santa Monica resident and advocate for children, early childhood education, affordable housing, and social justice.
