### **The board took action on the following:**

- The board adopted an annual resolution in honor of Week of the School Administrator, which is October 10-16 this year. This recognition celebrates our district's administrators and their dedication to the academic success and personal well-being of our students.
- The board held its annual public hearing on the sufficiency of instructional materials.

### **The board discussed the following:**

- Staff on the progress of our district's Sustainability Plan, which was adopted in March 2019 and focuses on minimizing our district's environmental impact; taking immediate action and promoting environmental stewardship and climate protection in an effective and measurable way; and making our district more resilient.
- Staff presented data on student assessment data from local measures administered last spring, including FastBridge, Renaissance Star Reading, UC/CSU math diagnostics, CAASPP, graduation and drop-out rates, meeting UC/CSU a-g requirements, AP exams, Early Development Instrument (EDI), College and Career Readiness benchmarks, English learner reclassification rates, ELPAC, student engagement survey, suspensions and expulsions, and student attendance.
- The board provided feedback on the draft charges for 2021-22 for the district advisory committees. These will return for action at the next meeting.
