II. Approval of Minutes May 9, 2013 meeting

A motion was made by Mr. Foster and seconded by Mr. Lee to approve the May 9, 2013 Minutes. The motion passed unanimously.

III. Staff Report: Chief Financial Officer Janece L. Maez (Limited Discussion)

A. <u>Budget Update</u>: Ms. Maez presented the Governor's May Revise. She announced that there will be about \$1.8B statewide funding for implementation of common core standards. Revenue limits that we have known them for the last 30 years will be gone. We will still use the revenue limit calculation during the phase in of Local Control Funding Formula (LCFF). The LCFF will be compared to the old formula and a percentage of the difference or "gap" will also be funded. The basic formula for LCFF has not changed since January.

For 2013-14 budget year, COLA is estimated at about 1.5%. It is expected that the level of funding should remain the same as last year. School Services of California has provided an online simulator that allows Districts to see what the funding would be in the current and subsequent years. They recommend using their more conservative amounts.

IV. Discussion/Action Items

- A. <u>Santa Monica-Malibu Education Foundation</u>: Ms.Greenberg-Gross provided an update of the Ed Foundation. She indicated that the master agreement between SMMEF and SMMUSD was approved by the Board of Education. Working with consultant who has helped focus the SMMEF Board to be strictly fundraising board. There are currently 14 members and they would like to expand to 21 members. Ed Foundation staff include: Office Manager-Yolanda Lewis, Program Coordinator-Rachel Faulkner, Director of Major Gifts- Ed Lin, and Director of Annual Fund and Leadership- Jessica Ureña. The Superintendent had six (6) community conversations over the past year. The fundraising goal is \$4M annually. The plan to raise this amount involves everybody in the community. The job is to continue to oversee the operations and staff as well as manage board's fundraising and planned giving.

- B. <u>FOC Vacancy</u>: There is one (1) vacancy on the committee due to the resignation of Stuart Smith. Ms. Maez informed the committee that PTA President Patti Braun was asked to assist in the recruitment of applicants, particularly from the Malibu area. The committee plans to solicit applications. A press release will be provided to make recommendation to the Board in August.
- C. <u>2012-2013 FOC Annual Report Discussion and Preparation for June 6 FOC/Board</u> joint meeting: Members discussed the content of the annual report to the Board that will include some of the committee's accomplishments such as meeting with Keygent, Decision Insite, extension of terms to match the school year, refunding of bonds, Measure ES, members involvement in district related activities such as Superintendent Advisory Committee.
