IV. Discussion/Action

7:38 pm A. July 16, 2014 joint meeting/study session with the Board of Education

The FOC commented on the joint meeting/study session with the Board of Education on July 16, 2014. In response to Dr. Escarce's comment for more member participation at the joint meeting, Mr. Lippman expressed he felt the meeting format was a report from the FOC chairman to the Board.

Mr. Larmore informed the committee of the Daily Press news article regarding Malibu unification that may trigger some interest on what the FOC will do. Ms. Slaugh Nahass would like to know what information AMPS already may have that would help the committee determine what still needs to be accomplished. Mr. Larmore suggested several subcommittees be established to work on different aspects of the Malibu Unification. The Board is expecting a plan in October on what the FOC is able do.

In response to Ms. Krenik's request for a Malibu cleaning update, Ms. Lieberman stated it should be completed within a week and a half and test results have been showing PCB concentrations lower than the EPA's acceptable exposure levels. In terms of how it relates to the unification, there is a lot of complexity for those who want the unification to happen. The environment may be relevant to the discussion of bond issues and liability. In response to the committee's question on how flexible the bond language is if the Measure ES Malibu committee wishes to spend all funds on PCB clean up, Mr. Lee informed the committee the ballot language is broad and projects are at the approval of the Board.

8:05 pm B. Recommendation from Nomination Committee

Ms. Torres informed the committee that a press release announcing vacancies on the FOC was sent on May 9, 2014, with completed applications due to the Superintendent's office by June 6, 2014. A total of eight (8) applications were received and considered. Three (3) of the applications were submitted by current FOC members and a subcommittee of the FOC interviewed each of the other five (5) applicants. There was consensus on the subcommittee to recommend that the current candidates be reappointed.
