- Stretch Budget: \$38,011

 - Family engagement
- Formula Budget: \$37,600
 - Campus monitors
- District, SLT, SMEF, Lottery, Gift, and PTA Budgets reviewed

Teacher Recommendations/Voting

- 68% of teaching staff voted;16 voted in favor of the proposed budget,1 abstained, 0 voted no
- If Title I money were available, 82% of teacher's voted for the Part-Time Intervention Teacher to return

ELAC Recommendations/Voting

- Member who attended the ELAC meeting was in agreement with the proposed SPSA, budget summary, and Parent and Family Engagement Policy and Compact with no suggested changes
