- CDE conduced a Federal Progress Monitoring review (audit) of SMMUSD in several areas such as compensatory education, physical education, English Learner programs, and Title I- the selected schools to represent the district were McKinley and JAMS. Dr. Benjamin shared that overall, McKinley did great. Interviews, observations, and document review occurred. The CDE spoke with members of ELAC and SSC and shared that parents and staff on these committees felt like they had a voice in what was happening at McKinley, and parents felt informed of programs and supports available to their child and felt they could ask questions if needed. CDE did classroom observations and noted how joyful students were and the positive classroom communities. Some findings were in the areas of PE and designated ELD. The district will make districtwide adjustments to address the findings.
- Parent Teacher Conferences: November 6th-November 9th

• No update on the start date of Construction yet. The contractor's cost is higher than expected, so aspects of the project may be cut to reduce costs. The district will also rebid the project in the spring to see if there may be lower bids. Also there was drycleaner fluid found in the soil underneath the parking lot blacktop where the construction would occur, so there is a process for approval of the encapsulation process that takes some time. Currently the drycleaner fluid is in the underground soil and not a hazard to students/staff/parents. Possible start date will be after spring break.
