

# PHASE 1 NEW HIGH SCHOOL PROJECT PROJECT UPDATE

## Plans & Specifications:

□ Increment 1 (*abatement/demolition/rough grading/underground utilities*): Submitted to DSA 11/24/21 and approved by DSA on 2/21/22

□ Increment 2 submitted to DSA: 1/12/22 (under review)

- DSA Comments: 06/10/22
- Anticipated DSA Approval: 9/27/22

# PHASE 1 NEW HIGH SCHOOL PROJECT SCHEDULE & BUDGET UPDATE

**Increment 1** (*abatement/demolition/rough grading/<del>underground utilities</del>)*:

- Original construction schedule: 6/1/22 to 10/31/22
- Out to Bid: 2/28/22
- Bids received: 3/24/22
- Pricing based on 5-month construction schedule
- Although shown in Inc. 1, all new site utilities were excluded from this bid and will be part of Inc. 2
- Cost of Increment 1 increased by \$368,969.00 in comparison to original preconstruction cost (\$3,091,984 to \$3,460,953)
- Increased demolition/abatement costs are due to cost of fuel & allowance for export of contaminated soil
- Pricing based on approval of GMP and award of contract before 5/31/22

## Increment 2:

Original construction schedule: 11/1/22 to 7/31/24

Staff and student occupancy of August 2024



# PHASE 1 NEW HIGH SCHOOL PROJECT SCHEDULE IMPACTS

## Increment 1 (6/1/22 to 10/31/22):

- Crucial summer window for Abatement & Demo would be lost
- Increased demolition noise impacts to instruction
- Roughly 2,500 hauling trucks expected for demo and rough grading
- Increased traffic impacts on Morning View Drive
- Guaranteed Maximum Price would be lost
- Bidding climate shows an increase of roughly <u>\$1 million in escalation for every</u> month we delay the start of this project
- New High School Project at risk of not being built due to potential budget impacts

## Increment 2 (11/1/22 to 7/31/24):

- Start of construction would be delayed
- Builder and Construction Manager "A Teams" at risk of taking on other projects
- August 2024 School Opening would be lost!
