# Architectural/Engineering Design Services Will Rogers ES HVAC RFP Questions & Answers March 17, 2020

- 1) How many Classrooms are in Classroom Buildings G and K (all other buildings list the number)?
  - a. Building K has 2 & Building G has 2.
- 2) Not seeing ADA work mentioned in the project scope though it might be implied in the Project Description. Is this included in the construction estimate of \$2,500,000?
  - a. There is no ADA work. HVAC will not trigger an access review at DSA.
- 3) What is the overall SF of all buildings?
  - a. 49,321 s.f. for permanent buildings, 9,600 for portable/modular.
- 4) Please confirm the number of cost estimates required and the phase where they are required as:
  - Page 12, Article III. HVAC Building Specific Scope Requirements per Building, Section I.
     Deliverables states "Schematic Design and 95% Construction Document Estimates"

but a Schematic Design phase is not mentioned elsewhere in the RFP and:

- Page 4, Article II. SCOPE OF SERVICES, Section 1. Assessment, General 9. states
   "Deliverable: Provide an estimate of construction cost based on the assessment findings and recommendations."
- Page 6, Article II. SCOPE OF SERVICES, Section 2. Design Development, General 9. states "Provide a DD Cost Estimate by a professional estimator."
- Page 8, Article II. SCOPE OF SERVICES, Section 3. 50% Construction Documents, 8. states "Provide a 50% Construction Documents estimate; confirm scope of work complies with budget allocation."
- Page 8, Article II. SCOPE OF SERVICES, Section 4. 95% Construction Documents, 8. states "Provide a 95% cost estimate prepared by a professional estimator."
  - a. Estimates shall be done as follows:
    - 1. At the completion of the Assessments by a professional estimator.
    - 2. At the completion of the Design Development by a professional estimator.
    - 3. At 95% completion of the Construction Documents (DSA Submittal) by a professional estimator.
