School Campus Improvement Project

Lead Agency: Santa Monica-Malibu Unified School District

Environmental Information: The Santa Monica-Malibu Unified School District (District), as lead agency under the California Environmental Quality Act (CEQA), has completed a Draft Initial Study/Proposed Mitigated Negative Declaration (IS/MND) for the John Adams Middle School Campus Improvement Project (Proposed Project) in accordance with CEQA. The District is providing notice in compliance with Title 14, Chapter 3, sections 15072 and 15073 of the California Code of Regulations, as amended. The IS/MND was undertaken for the purpose of determining whether the Proposed Project may have a significant effect on the environment with the implementation of mitigation measures. The IS/MND reflects the independent judgement of the District.

**Project Location:** The project site encompasses a 5.2-acre portion of the JAMS campus, located at 2425 16<sup>th</sup> Street in the City of Santa Monica, California. The project site is bordered to the northwest by the JAMS Performing Arts Complex along Pearl Street, to the southwest by 16<sup>th</sup> Street, to the northeast by 17<sup>th</sup> Street, and to the southeast by campus athletic fields along Ocean Park Boulevard. The JAMS campus is listed under Government Code section 65962.5 on a hazardous materials database (Department of Toxic Substances Control EnviroStor Database) for past cleanup actions, including the removal of polychlorinated biphenyls, asbestos-containing waste, waste oil, surplus organics, laboratory waste chemicals, and soils contaminated with lead and organochlorine pesticides. Because the contaminated soils and other hazardous wastes were disposed of off-site, this listing is not considered an environmental concern.

**Project Description:** The District is proposing improvements to the JAMS campus based on the 2020 Campus Master Plan. The purpose of the Proposed Project is to implement campus modernization efforts needed to align with the District's educational specifications. Overall, the Proposed Project would occur over four phases and would result in demolition of one existing building, construction of one new building, and renovation/reuse of six existing buildings over an approximate span of 10 to 15 years. Phase 1, which is currently funded, would include upgrading the existing library and courtyard. Subsequent phases would be constructed as funding becomes available and would include constructing a new Science, Technology, Engineering, Art, and Math building; creating a defined space for the 6<sup>th</sup>

grade cohort; modernizing the 8<sup>th</sup> grade courtyard; installing new hardscaping and landscaping within the central quad; and renovating the existing cafeteria.

**Public Review and Comments:** This Notice of Intent and accompanying MND and supporting reference materials are available for a 30-day public review period beginning November 14, 2022, and ending December 14, 2022. Physical copies of the MND and supporting documents are available for review at the District's Office at 1651 16<sup>th</sup> Street, Santa Monica, California 90405. The District's office is open from the hours of 9:00 a.m. to 5:00 p.m., Monday through Friday. The District invites you to comment on the IS/MND. Pursuant to CEQA Guidelines Section 15082, responsible and trustee agencies and other interested parties, including members of the public, must submit any comments in response to this notice no later than **5:00 p.m.** on December 14, 2022.
