- *Ms. Ipiña shared a summarized version of the plan with the goals and how we are trying to achieve*
- *SPSA School Plan for Student Achievement*
  - *Goal 1 : Whole District Academic- for all students*
    - *80% of all students meet or exceed the ELA and Math*
    - *40% or ELs in 3rd grade, 33% in 4th and 22% in 5th*
      - *Goal 1 To Meet Goal- Description of funds distribution*
        - *Achieve 3000 for 3-5- Inquiry from site council member*
  - *Goal 2: Multilingual Learners- Pertaining to English Learners*
    - *50% of 5th-grade students reclassify*
    - *Grow one level or maintain a level 4 ELPAC*
      - *A member asked if our demographics will meet the Title 1 this year*
      - *Ms Ipiña presented how we plan to target the goal using the Lesson link approach. She explained the distribution of the money.*
      - *Reach out to families in the immediate community so they know the benefits. There is a committee that works on recruitment. Second group that will be reached out will be people that work in the city.*
  - *Goal 3: Whole School Climate and Culture*
    - *Absenteeism to 13% as*
    - *SEL*
      - *Ms Ipiña explained the way funds are distributed for this goal. e.i. workshops, subs, leadership, dance teacher among the list. Singing teacher, Arts teacher ½ semester, multicultural books...*
