Meeting began at 3:47pm.

Minutes from 9.22.22 were approved (MaKenna Samsel moved to approve, Jennifer Gonzalez seconded).

Minutes from 10.22.22 were approved (Nancy Levy approved, Sonya Perl seconded).

Mr. Miller began the meeting by bringing up the parent survey which is voluntary, but helps promote safety, learning, and improving student achievement. He mentioned the awards program held this morning as well. *Noses Off*, the MHS musical show, begins tomorrow. Ms. Smith is attending a CTE (Career Technical Education) conference currently. There are a few classes at MHS that are considered "pathways" to CTE.

Elissa Marshall provided a PTSA update:

The Holiday Boutique was on Sunday, and the consensus is that it would be best to have that event during the week, but it went well overall. Red Ribbon Week was a success. Mr. Miller added that parents would like for students to receive more instruction/awareness about fentanyl. Mr. Ryan mentioned that he covers drug use in his Senior Seminar. MHS has 51 doses of Narcan on hand. There is discussion surrounding how to distribute the Narcan doses (should parents have training on how to administer it and give it to students to keep in their cars?).

Old business: Approval of CSSP

A summary of changes to the CSSP are:

All names edited to be current, especially within ICS structure Added second assembly area by MDF in quad for physical handicap Swapped out all maps Swapped out all contact numbers
Swapped out all list of students with disabilities
Swapped out disaster drill memo dates
Revised ingress/egress/traffic procedures with current protocols
Added specific language about school response in case of power outage
District will update suspension data
District updated specific board policies required by law

Mr. Miller walked the school ground with local authorities to look for safety improvements.

Nancy Levy moved to approve the additions to the School Safety Plan, listed above, and Jennifer Gonzales seconded. The motion was approved with all in favor.

Interim assessment results:

Mr. Miller shared student CAASP data. Student scores were underwhelming in several categories. These scores are supposed to help teachers see if they've reached their teaching standards. Teachers can see the actual questions to make sure they cover material that students may need extra instruction on. Ms. Gonzalez stressed the fact that students take so many tests and usually do not take them seriously as a result. Shane Perl agreed.

Student Voice:

Shane wondered if more water stations could be added around campus, particularly in the cafeteria. Mr. Miller and Mr. Ryan gave details on the difficulty the school went through to get the water stations that they have, so it is unlikely that they will be able to add more to campus. Customer service is very difficult to work with. The other issue that Shane brought up was that tampons and pads need to be added to the girls' bathroom.

Dual Credit/Concurrent Credit/Summer Get-Ahead Credit:

Elissa mentioned that a parent was wondering whether MHS students have the same get-ahead credit opportunities as other schools in the area. Ms. Samsel described SMMUSD's relationship with SMC and how dual credit works for GE requirements at certain schools. Get-ahead Geometry is available for MHS students, the only core requirement that is available to students. The Malibu SMC campus will be open in Spring 2023.

MHS Mission and Vision:

We visit this topic every 3-6 years. The mission and vision appear on the MHS website. We discussed potential ways to create meaningful, intentional additions to the mission/vision of MHS.
