- 5. ELAC Reports (15 min)

DELAC Vice President, Natalia Mikhnova

- Edison Veronica Ramirez reported on the two meetings this school year at their site. 10/11 The Fire Department did a presentation regarding safety in the home. The Vice Principal talked about the best way to communicate with classroom teachers during parent teacher conferences. 11/8 Meeting was about the ELPAC Test, Star Test, promoting a love for reading, after school program at Virginia Ave Park.
- **Grant Perla Garcia** reported they have had three meetings this school year. They have elected new representatives, learned the assignment for ELAC, what is ELAC by the principal. Discussed the

importance of the parent teacher conference evaluations, understanding ELPAC including communication with teachers to support EL students. The site had a cultural festival which has become more successful this year. People came from other schools. New families felt more connected.

- Franklin Natalia Mikhnova reported at the 10/27 meeting they elected two new members, welcomed new families, learned about the CREST program and the activities they provide. They have a small community of EL students and families. They discussed with the principal starting an international club at their site. The club would meet once a month so families can meet to discuss difficulties and share ideas.
- Malibu Elem Edgard Meinhart reported their site is working on getting enough reps
- JAMS Yadira Vazquez reported at their meeting last month (October), a representative from the police department talked about drug use. Asked if a parent can attend DELAC as a participant. Alex Aspron, the former BCL at JAMS, introduced the new BCL, Maria Salazar. This was her first day.
- Malibu High Delia Escobar reported the 11/14 Back to School will be in Spanish for the first time.
- McKinley Katerina Sterlyagova reported their first ELAC meeting was in September. The principal came to the meeting to talk about ELAC, its function and the purpose of ELAC. They elected new reps for ELAC and DELAC. Their next meeting will be this week.
- Rogers Nancy Orozco reported ELAC has met twice since the start of the school year. At the first

Ouestions and Answers (10 min)

DELAC President, Edgard Meinhardt

Eliana Uliatzeff. asked about EL programs prior to 4th grade

Dr. Williamson – Sites are to regularly give 30 mins of ELD time every day to students of all grade levels. There should be a core program with materials and is being worked on for grades TK-3.

Nancy Orozco asked how to find out how a child did on an assessment especially if they speak more English even if Spanish is spoken in the home. Especially if the child speaks little Spanish, why were they tested as an EL? Adela Rogers clarified if a child is part of a household speaking another language in the home, they are to be tested with the Initial ELPAC.

Nataliya Mikhnova – Younger students, K, 1st grades, taking the ELPAC test don't want to speak to strangers. Can the Test be administered by the child's teacher?

Dr. Williamson-The team going to the sites to test students is trained to work with children to make them at ease. The test is not given all at once. Part of the test is given as a group, part one on one.

Nataliya Mikhnova – If a teacher has three students speaking three different languages how can teachers spend 30 min per child per day?

Dr. Williamson-The district is working on a plan for training teachers

Yadira Vazquez-When students are enrolled in the district, they automatically receive a survey asking if students speak another language. If a child speaks English and not the home language, how do they get reclassified? Dr. Williamson-If parent says other language spoken in home, even if child only speaks English they must be tested. Information is sent with the ELPAC results regarding the qualifications for reclassification. Sites and ELAC should have the information to give to parents regarding testing and reclassification.

Laura Hernandez – Parents have lots of questions about testing and reclassification process. DELAC has asked the Board of Education to have a policy to include EL information with report cards. These questions are asked every year. ELAC reports to the Board should include this request.

Dr. Williamson-Finding from our Federal Monitoring Program shows the district needs to give feedback to parents. Whether it is in report cards or some other way is to be determined.

Alicia Mignano – This information should be in report cards. This is the only way parents can understand. Dr. Williamson – Letters sent home with score reports as required by the State of California. Sites need to give training to parents to help with their understanding.

Alicia Mignano. – We want to remind students that speak two languages will benefit them in their life. We want students to be successful in both languages. This is a process and we are improving every day. Alicia talked about her son's experience with testing. If a parent is unable to attend a meeting there may be a video to watch to find the information.

Maria Guadalupe Puga – Notify parents of survey, what it is regarding and notify parents ahead of time. Dr. Williamson – District staff are not allowed to guide parents when filling out the Home Language Survey (HLS).

Elgard Meinhardt – This presentation had given us very important information with ways to help students and parents.
