students' schedules, but all students' abilities to take UC-approved classes that are transferable to many colleges where AP classes may not be. Why is SMMUSD imposing this requirement now when the state law, AB-331, doesn't take effect until 2025?

A local educational agency, including a charter school, may require a full-year course in ethnic studies at its discretion. Commencing with the **2025–26** school year, a local educational agency, including a charter school, with pupils in grades 9 to 12, inclusive, shall offer at least a one-semester course in ethnic studies.
