Dear Malibu High School parents and guardians,

The Santa Monica-Malibu Unified School District is undertaking a project at Malibu High School to demolish Buildings A, B, C, D and E. Additionally, the district will be completing renovation activities in Buildings F, I, G and D. To safely renovate or demolish these buildings, the district has contracted with a specialized hazardous materials contractor to safely remove building-related hazardous materials such as asbestos, lead and PCBs. The environmental remediation work will be completed in accordance with applicable local, state and federal regulations.

The environmental remediation contractor's work will be completed using engineering controls including environmental containments using negative pressure isolation. All work will be completed by properly trained and certified personnel and contactors.

The remediation work will be monitored to document that the contractor's work is being completed in accordance with the project specifications and applicable regulations. Deviations from the written specifications will result in immediate work stoppage until the root cause is determined and an appropriate solution can be implemented. Air monitoring, including the use of real-time aerosol monitors, will be conducted on an ongoing basis to document that health protective action levels established for this site are not exceeded outside the contained work areas during the work. Additional environmental testing will be conducted prior to releasing the remediation areas.

Please observe all posted signage and do not enter posted construction or remediation work areas at any time. The health and safety of our students and staff is our top priority.
